

# Option 4 – UAB Recommendation

- Reduce GFT contribution by \$2.4m for FY18 and FY19 budgets
- Reduce capital budget from \$106m to \$85m to equal the amount of debt service modeled
- No additional increase to Communication budget
- No change to current 2 tier electric rate




### Option 5 –

- Change proposed base rate increase to 1% for Electric
- Increase vacancy rate to 8% from 6%
- Reduce reserves by \$500k
- Keep fuel adjustment at 70 Mills (Will review FA charge in 3 mos.)



#### Residential Electric


1,000 KWh June 2017
