Litigation

On August 30, 2017, this Office performed searches of litigation filed between January 1, 2009 through August 29, 2017 under the name of Gainesville Renewable Energy Center, LLC and GREC, LLC in the following courts: The Supreme Court of Florida, First District Court of Appeals, U.S. Northern District, and the Eighth Judicial Circuit. Note: Bankruptcy records are not included in this search because there is no central repository for such records.

The results of these searches are attached as Exhibit "A." The searches found no open litigation.

Uniform Commercial Code

On August 30, 2017, this Office performed a search through the Florida Secured Transaction Registry for records filed in the name of Gainesville Renewable Energy Center, LLC through August 25, 2017.

The results of this search are attached as Exhibit "B." The search found four filings: a UCC-1 Financing Statement filed July 5, 2011 between Gainesville Renewable Energy Center, LLC (as Debtor) and Union Bank, N.A. (as Secured Party) and three related UCC-3 Financing Statement Amendments filed March 23, 2016; March 24, 2016 and April 20, 2016.

Corporate Status

On August 30, 2017, this Office performed a search through the Florida Department of State, Division of Corporations for records filed in the name of Gainesville Renewable Energy Center, LLC to confirm active corporate status in the State of Florida.

The results of this search are attached as Exhibit "C." The search found that Gainesville Renewable Energy Center, LLC, is a Foreign Limited Liability Company, registered to do business in the State of Florida and is current on its annual report filings.
