21 Florida, adopted Resolution No. 160305 for the purpose of approving and adopting a final budget  
22 for Fiscal Year 2016-2017;

23                   **WHEREAS**, the City Commission adopted Resolution No. 160759, Resolution No.  
24 160955 and Resolution No. 170248 which amended Resolution No 160305 by amending the  
25 General Government Financial and Operating Plan Budget as set forth therein;

26                   **WHEREAS**, it is necessary to make certain amendments to the General Government  
27 Financial and Operating Plan Budget in order to fund their activities;

28                   **WHEREAS**, the City Commission desires now to amend the General Government  
29 Financial and Operating Plan Budget as fully set forth below.

30                   **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE**  
31 **CITY OF GAINESVILLE, FLORIDA:**

32                   **Section 1.** The General Government Financial and Operating Plan Budget for Fiscal  
33 Year 2016-2017 is hereby amended as set forth in Attachment "A" which is attached hereto and  
34 made part hereof as if set forth in full.

1           **Section 2.** Except as herein above modified and amended, the General Government  
2 Financial and Operating Plan Budget for Fiscal Year 2016-2017 as adopted by Resolution No.  
3 160305 and amended by Resolution No. 160759, Resolution No. 160955 and Resolution No.  
4 170248 shall continue and remain in full effect.

5           **Section 3.** This Resolution shall become effective immediately upon adoption.
