9	codifier; providing a severability clause; providing a repealing		
10	clause; and providing an immediate effective date.

13	WHEREAS, at least 10 days' notice has been given once by publication in a newspaper		
14	of general circulation notifying the public of this proposed ordinance and of public hearings to be		
15	held in the City Commission Auditorium, City Hall, City of Gainesville; and		
16	WHEREAS, the Public Hearings were held pursuant to the published notice described at		
17	which hearings the parties in interest and all others had an opportunity to be and were, in fact		
18	heard.		
19	NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE		
20	CITY OF GAINESVILLE, FLORIDA:		
21	Section 1. Sections 2-281 through 2-285 are amended to read as follows:		
22	ARTICLE V. BOARDS, COMMISSIONS AND COMMITTEES		
23	DIVISION 3. GAINESVILLE-ALACHUA COUNTY CULTURAL AFFAIRS BOARD		
24	Sec. 2-281 Created.		
25	The Gainesville Ceultural Aaffairs Bboard is hereby created.		
26	Sec. 2-282 Composition: appointment, term of members: filling of vacancies.		

The <u>Gainesville Ceultural Aaffairs Bboard</u> shall be composed of <u>ten (10)5</u> persons, ten of whom shall be appointed for three-year terms by the city commission. Members appointed by the city commission should have a strong interest in the arts and should represent a broad spectrum of society; including, but not limited to, practicing artists, recreation specialists,

1	business persons, educators, art historians, tourism professionals and citizens interested in arts	
2	advocacy.	

No member appointed by the city commission may be the owner or operator of, or consultant for, a for-profit enterprise engaged in the appraisal, sale, leasing or showing of art to the public on a retail or wholesale basis. Five appointments to the board shall be made by the county commission. The city Each commission shall fill vacancies for the unexpired terms of members-it appoints.

### 8 Sec. 2-283. - Duties generally.

The duties of the <u>Gainesville Ceultural Aaffairs Bboard</u> shall be to advise the city commission in regard to interest in and promotion of the arts and eco-heritage tourism, to develop local cultural resources and to assist the <u>director of cultural affairs Cultural Affairs</u>
Manager in the planning and implementation of community cultural involvement.

### 13 Sec. 2-284. - Committees.

The <u>Gainesville Cultural Affairs Board</u> director of cultural affairs may create, alter and abolish committees, which bodies shall advise the board and the director on matters concerning the cultural activities or programs desired by the citizens of the area. The <u>board</u> director shall determine the committees' composition, structure and duties, which shall be in full force and effect after approval by the chairperson of the cultural affairs board.

### 19 Sec. 2-285. - Selection of officers; meetings.

- 20 (a) The <u>Gainesville Coultural Aaffairs Booard</u> and its committees shall select one of their members as chairperson and such other officers as they may determine.
- 22 (b) The board and its committees shall meet at such time and place as provided in their rules 23 or procedures which rules shall also provide for the transaction of the business. Such 24 rules and procedures shall become effective after approval by the city commission.

**Section 2.** Sections 5.5-2 through 5.5-5 are amended to read as follows:

### 27 Chapter 5.5 ART IN PUBLIC PLACES

### Sec. 5.5-2. - Establishment of the Gainesville Aart in Ppublic Pplaces Ttrust.

(a) Creation. There is hereby created and established an Gainesville Aert in Ppublic Pplaces
 Ttrust.

1	(b)	Membership. Except as provided in subsection (1)a. below, tThe Gainesville Aert in
2		Ppublic Pplaces Ttrust shall consist of five (5) regular members, plus up to three (3)
3		temporary members for each project, as described below. No member of the Gainesville
4		Aart in Ppublic Pplaces Ttrust may be the owner or operator of, or consultant for a for-
5		profit enterprise engaged in the appraisal, sale, leasing or showing of art to the public on
6		a retail or wholesale basis. All trust members shall serve without compensation.
7		(1) Regular members.
8		a. Transition. In order to implement a consolidated City of Gainesville/Alachua
9		County Art in Public Places Trust, the number of regular members shall be temporarily
10		increased to seven as of April 1, 2001. The board of county commissioners shall appoint
11		two regular members to serve along with the five regular members already appointed by
12		the city commission. The two new members shall have terms ending September 30,
13		2002. The city-appointed members of the art in public places trust whose terms are
14		scheduled to end on September 30, 2002 shall be replaced as of October 1, 2002 by two
15		members appointed by the board of county commissioners, and the number of regular
16		members shall then be reduced back to five.
17		The 5 regular members shall be appointed for three-year terms by the city commission.
18		b. General. The city Each commission shall fill vacancies for the expired or
19		unexpired terms of the members it appointed. Except as provided in subsection (1)a.
20		above, the terms of office of the regular members shall be three years. Each term shall
21		end on September 30 of its respective year. No regular member shall serve more than
22		two consecutive three-year terms. Whenever possible, two of the five appointed
23		members shall be citizens with appreciation for the visual arts and three of the five
24		appointed members shall represent one or more of the following classifications: architect,
25		landscape architect or interior designer, professional in the field of art, and art or

(2) Temporary members. Temporary members shall change for each project and shall include the director of the division having jurisdiction over the public building being constructed and the authorized architect for the project, if the project is in or around the structure generating the funds. If there is no architect for the project, the city commission with jurisdiction over the project shall appoint an additional member representing one or

architectural historian.

- more of the classifications set out in subsection (b)(1). The <u>city</u> commission <del>with</del> jurisdiction over the project may appoint up to three citizen experts for each project that is not associated with a particular building. All temporary members will have voting privileges only for the particular project for which they were designated or appointed and will serve on the trust only for the project for which they were designated or appointed.
- 6 (c) Duties.

- (1) The trust will be responsible for development and implementation of the city public art master plan, through the art in public places trust program and for the management of the <u>Gainesville Aart in Ppublic Pplaces Ttrust Ffund</u>. The public art master plan must be reviewed by the city plan board and approved by the city commission.
- (2) The trust shall <u>evaluate and select</u> <del>recommend</del> works of art to the city commission or board of county commissioners</del> as described in section 5.5-4 below. Early in the design of a project, the <del>architect and department representative for the project shall work with the other</del> trust members to <u>shall</u> develop a plan for adding art to the project. When selecting works of art for a city project, the trust shall recommend to the city commission works of art that are in accordance with the public art master plan.
- (3) The trust shall also review any art project suggested, or offered to be donated, by another board or committee of the city or county, or by any citizen or group of citizens, or by the city commission or board of county commissioners, and make a <u>decision</u> recommendation to the city commission or board of county commissioners, as appropriate, on the suitability of the proposed project and any conditions to place on its execution.

### Sec. 5.5-3. - Art in public places trust fund.

(a) Fund. There is hereby created an Gainesville Aart in Ppublic Pplaces Ttrust Ffund consisting of all funds appropriated and deposited to the trust fund in connection with the construction or major renovation of public places. The trust fund is also authorized to accept gifts, grants and donations made to the city for art in public places. All appropriations, gifts, grants and awards of moneys for art in public places shall be deposited in an interest bearing account entitled the City of Gainesville Art in Public Places Trust Fund Account, which shall be a separate account established and maintained apart from the general revenue funds and accounts of the city. All interest earned in said

1	account shall accrue to the use and benefit of the trust fund account. Funds deposited or
2	credited to the <u>City of Gainesville</u> <u>Aart in Ppublic Pplaces Ttrust Ffund Aaccount and not</u>
3	expended by the close of any fiscal year shall be carried forward into the next succeeding
4	fiscal year.

- (b) Terms of existence. The <u>City of Gainesville Aart in Ppublic Pplaces Ttrust Ffund</u>
   Aaccount shall be self-perpetuating from year to year unless specifically terminated by the city commission.
- Trust fund income. Each appropriation for the original construction or major renovation 8 (c) of a city building where public employees work on a regular basis or that the general 9 public uses shall include an amount of at least one percent of the total construction 10 budget for the art in public places trust. The total appropriation for the trust fund from 11 any single project shall not exceed \$100,000.00. All city departments and agencies shall 12 include, in all budgets or applications for funding for capital improvement projects to 13 granting organizations or governmental agencies, an amount equal to at least one percent 14 of eligible construction costs for the Gainesville Aart in Ppublic Pplaces Ttrust. All 15 appropriations shall be deposited in the City of Gainesville Aart in Ppublic Pplaces Ttrust 16 Ffund Account when the construction or renovation begins. 17
  - (d) Trust fund expenditures. Monies may be used in accordance with the requirements of this section for all costs associated with acquiring and commissioning art for public places, including costs for administration, travel, training, postage, printing, grants match, and education workshops. These costs may not exceed 20 percent of the total budget. Bond funds shall be appropriated and accounted for in the bond capital project accounts. Any gifts, grants and awards received subject to a condition shall be expended strictly in accordance with that condition. If an appropriation is not used for the acquisition of art for the public place for which it was appropriated, it shall be retrained in the trust fund to supplement other appropriations for the acquisition of art under this section or to place art in, at, or near public buildings which are already in existence. Upon request of a charter officer, tThe trust eity commission may authorize the trust to suggest projects to be paid for from retained funds. The charter officer or designee appointed by the city commission and representing one or more of the classifications set out in subsection 5.5-2(b)(1) will be substituted for the division manager and architect usually on the

committee. It is not the intent of this section to prohibit the expenditure of an amount greater than the amount allocated pursuant to section 5.5-3(<u>ca</u>).

## Sec. 5.5-4. - Selection procedures.

All acquisitions shall be in accordance with the terms of this chapter. Additionally, acquisitions for county projects shall be in accordance with the terms of the county's art in public places program. Whenever possible, a national call to artist request for qualification (RFQ) or other formal solicitation should be widely broadcast. Finalists, and ultimately the final selection(s), are made by the trust through a deliberative process, or the trust shall recommend three possible selections for each acquisition to the commission having jurisdiction over the project. The commission shall then make the final selection for each acquisition from the recommended selections, or the commission may reject all recommended selections. The charter officer or designee shall negotiate and execute all appropriate contracts for art selected by the eity commission. Funds from multiple capital projects may be aggregated to acquire the art.

- (1) Selection criteria. The intent of the art in public places program is to select and provide works of art through a creative collaboration among the public, artist and architect and/or project representative. Therefore, the trust discusses physical and aesthetic considerations including the following:
  - a. Art shall be located in areas where residents and visitors live and congregate and shall be in accordance with the goals of the public art master plan.
  - b. The trustees should consider the impact of public art on the lives of those frequenting public places. Art reflecting enduring artistic concepts, not transitory ones, should be sought.
  - c. The trust's selections must reflect the cultural and ethnic diversity of this city without deviation from a standard of excellence.
  - d. Final selection shall also take into account appropriateness to the site, permanence of the art in light of environmental conditions at the site, maintenance requirements, quality of art, likelihood that the artist can successfully complete the art within the available funding, diversity of art already acquired by the trust, and diversity of the artists whose art has been acquired by the trust.
- (2) Supervision of contracts. The charter officer is responsible for contracting with the artist for the commission or purchase of art by the city. The contract is negotiated

2	the following:
3	a. A description of the art to be commissioned or purchased.
4	b. Site and base or footing preparation.
5	c. A price and payment schedule.
6	d. An installation and time schedule.
7	e. The transfer of ownership to the city.
8	f. The artist's right to claim authorship and all rights secured under federal copyright
9	laws.
10	g. The artist's rights regarding changes, repairs or relocation of the art.
11	h. The charter officer is responsible for contract supervision and for the performance
12	of the work specified in the contract. The charter officer facilitates installation of
13	the art with the artist advising concerning the installation. The charter officer

# Sec. 5.5-5. - Ownership and maintenance.

Unless otherwise provided, ownership of all art and architectural enhancements acquired by the city under this chapter is vested in the city, including copyrights, patents and other reproduction rights. The city shall be responsible for managing the reproduction rights of each acquisition with advice and counsel from the art in public places trust. The responsibility for maintenance, insurance and restoration of each artwork shall rest with the city and the art shall be maintained by the charter officer with advice from the Gainesville Aart in Ppublic Pplaces Ttrust.
