AGENDA STATEMENT

170767. After and Out-of-School Programs (NB)

Listed below are remarks/suggestions from the City and County.

Mayor Poe expressed a desire that the City/County coordinate after school programs. He stated that the County Commission asked the City Commission to look into ways we could offer support to provide meaningful activity to all children in the community, especially during times that school activities are not provided. The Racial Disparity Report of the Friendship 7 had two findings that were unanimous: 1) We need to pull our resources together to solve some of these problems; and 2) most effective way to reach all children with academic support, character building programs – all best conducted at the school itself. One of the biggest barriers is transportation so providing services where they already are would solve a lot of problems. Whatever the path forward is, it needs to be jointly with an Advisory Committee (with representation from all boards so everyone's interests are taken into consideration). Mayor Poe requested that all parties agree that this is what we need to focus on.

Michelle Park, Assistant Parks, Recreation and Cultural Affairs Director stated that transportation was not studied (in depth) because there were no transportation experts on the board, but it was identified as a challenge that needed more attention.

Commissioner Warren stated that she attended the Youth Summit and also heard the challenge of transportation.

Mayor-Commissioner Pro Tem Budd stated that a lot of the afternoon programs are in silos and he would like to see coordination, to understand the needs of students and parents (what's done after school). How do we integrate the bus system to be a better system for the community.

Commissioner Goston stated that the main problem on the east side is the distribution

of education that contributes to gang violence and mischief. Some issues can be resolved by those on the east side by spending more time with our children (focusing on educational activities). District 1 schools are the lowest performing in the district and they deserve to receive the same amount of attention as the other schools in the county. He stated that the Emissary Program is a great example of a program that works. We have to involve the community, to the source of the issue, to find out what is really needed.

Commissioner Cornell stated that as a member of the MTPO, he supports using any excess capacity through RTS for transportation to any places that need it, especially those related to this initiative and the delivery of those services.

Mayor Poe will place on a future agenda for discussion an Action Plan.
