	A resolution of the City Commission of the City of Gainesville, Florida, calling a special election to be held on June 12, 2018; submitting a referendum on annexation to a vote of the registered electors of an unincorporated area of Alachua County known as "Finley Woods Phase I," as described in detail by Ordinance No. 170762; providing ballot language; providing directions to the Clerk of the Commission; and providing an effective date.
10 11	WHEREAS, the Municipal Annexation or Contraction Act, Part I of Chapter 171, Florida Statutes
12	(the "Act"), sets forth criteria and procedures for adjusting the boundaries of municipalities
13	through annexations or contractions of corporate limits; and
14	WHEREAS, on February 15, 2018, and in accordance with Section 171.042, Florida Statutes, the
15	City Commission of the City of Gainesville approved an Urban Services Report setting forth the
16	plans to provide urban services to the subject property; and
17	WHEREAS, on April 19, 2018, the City Commission of the City of Gainesville adopted Ordinance
18	No. 170762, an annexation ordinance that proposes to annex approximately 23.40 acres or
19	property known as "Finley Woods Phase I" that is described in detail in the ordinance; and
20	WHEREAS, pursuant to the Act, Ordinance No. 170762 shall be submitted as a referendum or
21	annexation to a vote of the registered electors of "Finley Woods Phase I"; and
22	WHEREAS, Ordinance No. 170762 provides that the referendum on annexation shall be held
23	during a special election to be conducted by the Alachua County Supervisor of Elections by mai
24	ballot on June 12, 2018; and
25	WHEREAS, Sections 9-4 and 9-5 of the Code of Ordinances of the City of Gainesville provide
26	that special elections shall be ordered by a resolution of the City Commission instructing the
27	Mayor to issue a proclamation calling the special election, with such proclamation published in

a newspaper of general circulation at least 30 days prior to the special election.

SECT	ON 3. The Clerk of the Commission is authorized to publish the proclamation and notice	
of th	e referendum election on annexation as prescribed by law.	
SECT	ON 4. This resolution shall become effective when Ordinance No. 170762 becomes	
effec	ive.
