An ordinance of the City of Gainesville, Florida, amending the Future Land Use Map of the Comprehensive Plan by changing the land use category of approximately 8.33 acres of property generally located at 6224 SW 20th Avenue, as more specifically described in this ordinance, from Alachua County High-Density Residential to City of Gainesville Residential Low-Density (RL); providing directions to the City Manager; providing a severability clause; providing a repealing clause; and providing an effective date.

- 11 WHEREAS, Section 163.3167, Florida Statutes, requires the City of Gainesville to maintain a
- 12 Comprehensive Plan to guide the future development and growth of the city; and
- 13 WHEREAS, the City of Gainesville Comprehensive Plan, as required by Section 163.3177(1),
- 14 Florida Statutes, must provide the principles, guidelines, standards, and strategies for the
- 15 orderly and balanced future economic, social, physical, environmental, and fiscal development
- 16 of the city as reflected by the community's commitments to implement such plan; and
- 17 WHEREAS, Section 163.3177(6), Florida Statutes, requires the City of Gainesville
- 18 Comprehensive Plan to include a Future Land Use Element with a Future Land Use Map that
- 19 designates the future general distribution, location, and extent of the uses of land for
- 20 residential, commercial, industry, agriculture, recreation, conservation, education, public
- 21 facilities, and other categories of the public and private uses of land, with the goals of
- 22 protecting natural and historic resources, providing for the compatibility of adjacent land uses,
- 23 and discouraging the proliferation of urban sprawl; and
- 24 WHEREAS, this ordinance, which was noticed as required by law, will amend the Future Land
- 25 Use Map of the Comprehensive Plan by changing the land use category of the property that is
- 26 the subject of this ordinance; and

27 WHEREAS, the amendment to the Future Land Use Map of the City of Gainesville Comprehensive Plan proposed herein involves a use of 10 acres or fewer and qualifies as a small-scale development amendment as provided in Section 163.3187, Florida Statutes; and 29 WHEREAS, the City Plan Board, which acts pursuant to the authority granted in Section 4.02 of the Charter Laws of the City of Gainesville and which acts as the Local Planning Agency 31 pursuant to Section 163.3174, Florida Statutes, held a public hearing on January 25, 2018, and voted to recommend that the City Commission approve this Future Land Use Map amendment; and 34 WHEREAS, at least five days' notice has been given once by publication in a newspaper of general circulation notifying the public of this proposed ordinance and of a public hearing in the City Hall Auditorium located on the first floor of City Hall in the City of Gainesville; and WHEREAS, at least thirty (30) days' notice has been given by mail to each real property owner 38 whose land will be redesignated by enactment of this ordinance and whose address is known 39 by reference to the latest ad valorem tax records, notifying such property owners of this 40 proposed ordinance and of a public hearing in the City Hall Auditorium located on the first 41 floor of City Hall in the City of Gainesville; and 42 WHEREAS, the public hearing was held pursuant to the notice described above at which hearing the parties in interest and all others had an opportunity to be and were, in fact, heard. - 47 **SECTION 1.** The Future Land Use Map of the City of Gainesville Comprehensive Plan is 48 amended by changing the land use category of the following property from Alachua County 49 High-Density Residential to City of Gainesville Residential Low-Density (RL):
- See legal description attached as **Exhibit A** and made a part hereof as if set forth in full. The location of the property is shown on **Exhibit B** for visual reference.
- In the event of conflict or inconsistency, **Exhibit A** shall prevail over **Exhibit B**.

- 54 **SECTION 2.** The City Manager or designee is authorized and directed to make the necessary 55 changes to maps and other data in the City of Gainesville Comprehensive Plan in order to 56 comply with this ordinance.
- 57 **SECTION 3.** If any word, phrase, clause, paragraph, section, or provision of this ordinance or 58 the application hereof to any person or circumstance is held invalid or unconstitutional, such 59 finding shall not affect the other provisions or applications of this ordinance that can be given 60 effect without the invalid or unconstitutional provision or application, and to this end the 61 provisions of this ordinance are declared severable.
- SECTION 4. All ordinances or parts of ordinances in conflict herewith are to the extent of such conflict hereby repealed on the effective date of this amendment to the Comprehensive Plan.

 SECTION 5. This ordinance shall become effective immediately upon adoption; however, the effective date of this amendment to the City of Gainesville Comprehensive Plan, if not timely challenged, shall be 31 days after adoption. If challenged within 30 days after adoption, this amendment shall become effective on the date the state land planning agency or the Administration Commission issues a final order determining this amendment to be in
