






Infrastructure Overview

- Site Work Construction Awarded to O'Steen Bros Via Competitive Bid for ~\$2.6 million (Oct 2017)
 - Earth Work, Streets & Sidewalks
 - Tree Preservation and New Landscaping
 - Wetland Improvements
 - Storm Water Pond Including Nature Trail Feature
 - Lighting, Signage, Trail Wayfinding
 - Utility Infrastructure Including Sewer, Water, Underground Electric
- Anticipated Site Work Completion = Q4 2018





Solicitation Evaluation Decision

- May 24, 2018 The Evaluation Team Met and Unanimously Ranked Modera Home Builders as the Most Responsible and Responsive Bidder Based on the RFP Evaluation Criteria
- Modera Home Builders Demonstrated to the Evaluation Team That They Provided the Most Comprehensive Value in Connecting With the Vision and Scope of the Project
- Letter of Award Issued on May 29, 2018 by City Purchasing Department

Next Steps....

- 1. Formalize a legal agreement between the City and Home Builder(s)
- 2. Continue overseeing the site construction
- 3. Coordinate marketing efforts with home builder contractor
- 4. Facilitate the relationship between the potential home owners and home builder
- 5. Continue to collaborate with Gainesville East Campaign

Recommendation

CRA Executive Director to CRA Board:

- 1) Approve selected contractor from RFP to build up to 1/3 of the home sites,
- 2) Open up to 1/3 of the home sites for builders to purchase, and
- 3) Work with the General Government Housing Division to partner on affordable housing for up to 1/3 of the home sites.
