Dear Mayor Poe,

At the June 14, 2018, Alachua County Commission Special Budget meeting, the Commission discussed the prioritization of upcoming road projects. The Board received the proposed Capital Improvement Program and received updates of several projects within the City of Gainesville limits.

The following motion passed unanimously with Vice-Chair Chestnut and Commissioner Byerly out of the room:

Move that the Board issue a Chair letter to the City, reminding them of the cost spent on repaving 16th Avenue from 13th Street to 43rd Street and asking them to take ownership of 16th Avenue from Main Street to 43rd street prior to beginning the paving of 13th Street to Main Street.

The budget or cost for the above projects is currently estimated at:

1. NW 16th Avenue (NW 13th Street to NW 43rd Street):

\$8,203,964.00 (Project completed)

2 NW 16th Avenue (NW 13th Street to N. Main Street):

\$1,270,000.00 (Completion, FY 2019)

The Commission would like nothing more than to further discuss these important road projects within the City of Gainesville limits. I look forward to your feedback on this issue.
