Re: Hazard Mitigation Grant Program (HMGP) applications for FEMA 4337-DR-FL, Hurricane Irma

Dear Mr. Anderson:

The Alachua County Local Mitigation Strategy (LMS) working group has approved by vote and prioritized the following projects for HMGP funding from this disaster. These projects align with our LMS goals and objectives as noted, and with the State's mitigation goals and objectives (in accordance with the Code of Federal Regulations 44 §201.6). The proposed projects support the attainment Alachua County LMS Goal 3 and its associated objectives to engage in hazard mitigation project planning and implementation to protect public health and safety, economic vitality, property, natural and cultural resources, critical facilities, and governmental buildings and facilities.

The Alachua County LMS grouped the projects into large and small projects. The first three projects below are the large projects listed in the order they are to be considered for funding and the last seven projects are the small projects ranked in their funding priority order. HMGP applications will be submitted for all of these priority projects.

Based upon an overall ranking of all of our proposed hazard mitigation projects, we have developed a list of secondary projects – both large and small – that we would substitute should a primary priority project be rejected for whatever reason after the HMGP application has been submitted to the Florida Division of Emergency Management. HMGP applications will also be submitted for these secondary backup projects.

The projects on the attached list are the secondary projects that the Alachua County LMS Work Group would substitute for any of the priority projects listed above should they be rejected during the HMGP review process. This secondary project list is in ranked order so that if any priority project is deemed to be ineligible, we would go to the first project on this list. So that we may efficiently use as much of the HMGP funding "allocated" to Alachua County as possible, estimated project cost is also a consideration. That is to say, if a priority project is deemed ineligible we would want to select a project from the ranked order secondary list of a similar estimated project cost. If the large secondary projects are deemed ineligible then we would move to a combination of smaller projects.

Alachua County HMGP Secondary Project List

In the event that any primary projects are determined to be ineligible for HMGP funding, or are otherwise determined to not be feasible then replacements will be selected from the following projects first by ranked order and then by project cost so as to efficiently use the HMGP "allocation":

1. City of Gainesville Airport Runway Creek Stabilization –

Project is to stabilize the bank of Little Hatchett Creek where it traverses the east end of the Gainesville Regional Airport runway clear zone. During Hurricane Irma erosion occurred along the channelized section of the creek. The project would regrade and re-vegetate the stream banks to stabilize them and prevent erosion.

Estimated Total Project Cost:

\$1,000,000

Estimated Federal Share:

\$ 750,000

2. Alachua County Oak Crest Eagle Point Chelsea Lane Basin Expansion -

Project would expand an existing storm water basin to provide additional storage volume. In the 2004 hurricanes and during Hurricane Irma two houses were flooded and several houses were threaten with flooding in the area.

Estimated Total Project Cost:

\$ 950,000

Estimated Federal Share:

\$ 712,500

3. Gainesville Regional Utilities Messenger Wire Projects –

Removal of non-conductor "messenger wires" from power distribution system to enhance system reliability and hasten restoration process. Messenger wire removal projects are in ranked order.
