On <u>October 31</u>, <u>2013</u> after the expiration of a period of at least 90 days, the Owner was notified via <u>legal ad in the Gainesville Sun</u> of the intention to record a lien against the Property.
- 8. That the Owner has failed to pay the amount due within five days of service of the date of delivery of the notice of lien.
- 9. That the City of Gainesville claims a lien against the above-described Property for the sum of \$1300.00.
