


REQUESTED DATA

The Crime Analysis Unit at the Gainesville Police Department conducted an analytical objective regarding the three geographical locations of the ITM Group Treatment Centers. In addition, a radius within a ½ mile of the three locations were also observed for sex offenses committed by sex offenders/predators.

MAP OVERVIEW OF ITM GROUP TREATMENT 1607691



ANALYTICAL FINDINGS




- Alachua County has 405 Registered Sex Offenders/Predators, according to the Florida Department of Law Enforcement Sex Offender & Predator Database, 2017.
- There are a total of 275 registered sex offenders/predators that resides within the City of Gainesville.
- A total of 12 sex offenses were committed by sex offenders/predators within a ½ mile radius of one of the three ITM Group Treatment Centers.
- Offenses included, 1 lewd & lascivious act to a child under 16, 1 sexual battery, 3 failure to register as a sex offender, and 7 computer sex crimes.

ANALYTICAL FINDINGS CONTINUED

- The offense of lewd and lascivious act to a child under 16, involved an adult male suspect and a 14 year old female. The offense took place in an apartment complex parking lot located within a $\frac{1}{2}$ radius of a ITM Group Treatment Center location. The offender was arrested.
- The offense of sexual battery involved a 14 year old female and her mother's live-in boyfriend within their home. The offender was arrested.
- Offenses of computer sex crimes were a result of an operation, Internet Crimes Against Children, held by the Gainesville Police Department. The Gainesville Police Department is located within a 1/2 mile radius of the 1208 NW 6^{th} Street address, hence the reported location, the offenses occurred at various locations throughout the city.
