The Glock company recognizes three companies in the State of Florida as direct sale representatives to sell their handguns to Law Enforcement Agencies in the State of Florida. These companies sell the handguns at a price that is set by Glock, therefore, the price will be the same from the three available vendors. Out of the three Glock recognized companies, Lou's Police Distributors qualifies as a women and/or minority owned company. The Police Department currently issues a 40 caliber Glock and is switching to the 9mm units due to improved accuracy as verified by FBI testing and lower cost for 9mm amounttion. Staying with Glock allows the Police department to use the same accessories (holsters and magazine pouches). Switching to another manufacturer would require replacement of all accessories at an additional cost of approximately \$24,000. Additional training would be required to implement the use of weapons produced by a different manufacturer.
