

To the extent possible, members of the advisory board should live or work in the community reinvestment area. Each member shall be appointed for a term of two (2) years and shall hold office until a successor has been appointed and qualifies. Vacancies shall be filled by appointment of the City Commission for the unexpired term of any member whose term becomes vacant. The advisory board should meet monthly and may adopt rules of procedure, subject to approval by the City Commission, to govern the conduct of its meetings. Staff support for the advisory board will be under the direction of the City Manager.

Applicants are encouraged to submit a resume and any additional information relevant to their application.





Mr. Mayor and Members of the Gainesville City Commission:

The majority of my productive life has been directly associated with redevelopment within the urban core of Gainesville. I've spent the past 40 years renovating dilapidated old houses in two of the City's former CRA redevelopment districts -- Fifth Avenue/Pleasant Street and College Park/University Heights. I lived in the NW Fifth Avenue neighborhood for 30 years. I own a small handful of properties in both of these (former) districts and continue my work there on a daily basis. I am a State Certified Residential Building Contractor.

My first appointment to a Gainesville advisory board was to the Historic Preservation Board in 1992. I was subsequently appointed to the College Park/University Heights Redevelopment Advisory Board as a charter member in 1995 (where I also served as chair). While serving on the CP/UH Board, I initiated and was the principal architect behind the University Heights Special Area Plan, which established detailed development requirements (street trees, sidewalk widths, appropriate building setbacks, angle of light obstruction limits, etc.) for the University Heights portion of the redevelopment district.

I've served twice on the Fifth Avenue/Pleasant Street Redevelopment Advisory Board. I also resigned twice from the Fifth Avenue/Pleasant Street Redevelopment Advisory Board.

I served one term on the City's Development Review Board and two terms on the City Plan Board (where I also served as chair). Our Plan Board work included reviewing all land use and zoning applications, all special use permits, and the 10-year review and update of Gainesville's Comprehensive Plan.

I moved to the Stephen Foster neighborhood in 1996 and have served as president of the Stephen Foster Neighborhood Association for the past 12 years. Remediation and future redevelopment of the 150-acre Cabot/Koppers Superfund site is our most pressing issue, as the neighborhood shares a milelong boundary with the site. I also serve on US EPA's Technical Assistance Services for Communities (TASC) team and attend the Alachua County Environmental Protection Department's Cabot/Koppers Local Intergovernmental Team (LIT) meetings in both capacities.

If managed appropriately, the GCRA should function as an economic investment mechanism that encourages and facilitates private-sector reinvestment into areas that are suffering from blight — which in turn benefits the community at large. Redeveloping areas of the city that are suffering from financial disinvestment should be one of the highest priorities of our local government. I've been a long-time advocate for unifying Gainesville's redevelopment districts and I look forward to serving on the GCRA Advisory Board, if appointed.
