

Plurality Voting

Plurality voting is when there are more than two candidates in a race and the one that receives the most votes (but not a majority of the total votes) is considered the winner or it requires a subsequent runoff race between the top two vote getters.


PROBLEMS WITH OUR CURRENT SYSTEM









2016 Republican Presidential Primary





The plurality system is the **spoiler**.

Fails to guarantee majority winners

Fails to eliminate the spoiler effect

Discourages candidates from running

Limits our choice in the voting booth



THE SOLUTION

Ranked Choice Voting

Instead of picking just one candidate, **Ranked Choice Voting** lets you rank multiple candidates **in the order you prefer them.**



RANKED CHOICE VOTING SAMPLE BALLOT

A. To vote, fill in the OVAL to the right of the candidate of your choice like this .

B. If you wrongly mark, tear or spoil the ballot, return it and get another.

- Rank candidates in order of preference.
- Fill in the ① next to your first choice.
Fill in the ② next to your second choice.
Fill in the ③ next to your third choice.
- Do not fill in more than one oval per candidate. Do not fill in more than one oval per column.
- Ranking a 2nd, 3rd, etc. choice candidate will not hurt your first choice candidate.

To win under **Ranked Choice Voting**, a candidate must get a **majority of the votes** (>50%), either in the first round, or in the “instant runoff.”



Why RCV Makes Sense for Florida

Florida is a **swing state**.

Political affiliation: 37% Democrat, 35% Republican, and **27% No Party Affiliation**.

While Florida still has portions of it that are very “**red**” or “**blue**”, on the whole **the state is solidly purple**.

Last 3 Governors races were decided by **less than 2%**.

The outcome of close elections are easily swayed by third party candidates. **RCV fixes this**.



Ranked Choice Voting Benefits

Allows all the voters to express all their preferences

Increases voter turnout

Rewards positive campaigning

Saves cost of run-off elections

RCV Rewards Positive Campaigning!



10-Point Higher Turnout. No New Voter Errors.

An expansive October 2016 study by University of Missouri-St. Louis (Dr. David Kimball and Joseph Anthony) examines the impact of ranked choice voting (RCV) on voter turnout in 26 American cities across 79 elections.

The UMO study shows that the adoption of RCV is associated with:

- A **10-point increase in voter turnout** compared to primary and runoff elections.
- No change in turnout in the General Election.
- No change in the number of error votes (overvotes and undervotes).
- No change in inequities in voter turnout and error votes in Minneapolis.



Voters Utilize Rankings

87%

of voters in Maine's first RCV statewide Democratic Primary ranked multiple candidates.

88%

of voters in Santa Fe's first RCV election ranked multiple candidates for mayor.

61%

of those Santa Fe voters ranked all five candidates.



RCV is a real and practical solution.

Eliminates spoilers and vote-splitting.

Encourages more people to run.

Curbs negative campaigning.

Gives voters **more voice** and **more choice**.

Can transform politics in Florida, and the Nation.



In the 243-year history of the U.S., there have been 38 significant changes to voting rights at the federal level. **That's an average of one change every 6 years.**

Change is not the exception -- it's the rule.





Florida Campaign

In 2007, Sarasota voters enacted RCV with 78% of the vote.

The Florida Department of State is stonewalling democracy.



The people have spoken, but the state isn't listening.

Now, Sarasota local officials and voters are waging a legal and public pressure campaign to ensure that **Governor DeSantis** and **Secretary Laurel Lee** do the right thing.
