#### Partnership – Pilot Focus Area: Food Systems

#### **Establishment of the Food System Coalition (FSC)**

- What is the FSC? A grassroots coalition of diverse local stakeholders who are working to improve our local food system for our larger community. The FSC is NOT an extension of any existing organization or agency.
- <u>Mission:</u> Improve accessibility, justice, and sustainability of our local food system.
- <u>Participants:</u> Local government staff, non-profits, small food-based business owners, local farmers, gardeners, faculty, students, healthcare professionals, etc.
- <u>Structure:</u> Monthly meetings, 3 Working Groups, Steering Committee

#### **Food System Coalition**





#### What is the Food System Coalition (FSC)

A grassroots coalition of diverse local stakeholders who are working to improve our local food system for our larger community. The FSC is NOT an extension of any existing organization or agency, but rather a cooperative space where people representing different sectors of the food system can come together to collaborate.

#### What is the FSC Mission

To improve accessibility, justice, and sustainability of our local food system

#### How do we achieve our mission?

- By offering support (i.e. information, advice, resources, and social networking opportunities) and facilitating collaboration amongst diverse stakeholders engaged in projects, programs, and policy initiatives that aim to improve our local food system
- By identifying policies and procedures that impede improvement of our local food system and proposing solutions.
- By developing and/or participating in topic area projects that improve healthy food access in high-need communities of Alachua County and support economic models that benefit our local producers.

#### **Role of FSC in Partnership Model**

- The Partnership for Reimagining Gainesville refers neighbors/community partners to the FSC to gain additional support (e.g. resources, information and social networks) around early-stage project ideas.
- FSC members may develop proposals and/or participate in initiatives that center on collaboration and may seek support from the Partnership (i.e. draft Urban Agriculture Ordinance public feedback process)





#### Partnership – The Partnership Model: What We've Learned

To be successful in supporting the Gainesville community, the Partnership Model needs to:

- Require a **commitment** from Anchor Institutions **beyond funding** alone to build long-term impact together with community stakeholders.
- Facilitate new collaborations that are **relatable to community needs** and take their cue from grass-roots activities.
- Support collaborations and activities that build capacity in the community together with key community stakeholders.
- Ensure a community-driven focus by including community members throughout the whole process... both the ideation process and the doing.
- Be **flexible** and **iterative** in the design and implementation process to accommodate the needs of all parties involved, ensuring mutual benefit and reciprocity are achieved.





#### Partnership Model –

### Key components for mutually beneficial impact

(1 of 4)

The Partnership Model needs to identify and evaluate ideas through a process that:

- Engages the community at a grass-roots level
- Places value on all forms of knowledge and experience
- Works closely with other partners to leverage knowledge, experience and resources

- United Way of North Central Florida - provide technical platform
- Neighbors and community partners - provide experience, knowledge and community assets
- Networks of focus area stakeholders (e.g. the Food System Coalition) - refer interested parties to the Partnership for Reimagining Gainesville for additional support





#### Partnership Model –

### Key components for mutually beneficial impact

(2 of 4)

The Partnership Model needs to support and resource ideas through a process that:

- Leverages resources among a diverse consortium of stakeholders in the community.
- Encourages collective capacity building, rather than competition among silos.

- UF + City - funding (\$75,000 each) and technical expertise
- Community Foundation of North Central Florida - fiduciary agent
- United Way - advisory support and network of experts
- Networks of focus area stakeholders (e.g. the Food System Coalition) - access to resources and social networks





#### Partnership Model -

### Key components for mutually beneficial impact

(3 of 4)

The Partnership Model needs to **evaluate and assess outcomes** of ideas:

- To improve measurable and sustainable social impact that is relevant to community needs.
- By using evaluation tools that are co-designed by all stakeholders involved.

- United Way - accountability partner for tracking impact
- UF + City - knowledge and competence in the form of researchers, staff and students as well as data and analysis support
- Community stakeholders - evaluating the relevance and significance of impact





#### Partnership Model –

### Key components for mutually beneficial impact

(4 of 4)

The Partnership Model needs to promote sustainable impact and capacity building by:

- Facilitating long-term impact through co-creation, innovation and implementation of outcomes.
- Supporting capacity building through long-term collaborations and partnerships.
- Identifying resources to leverage to facilitate adapting, sharing and up-scaling of successful outcomes.

- New partnerships and collaborative relationships that are established through the Partnership Model
- Anchor Institutions that benefit from key outcomes
- Non-profits and private organizations that benefit from and implement key outcomes
