

## **Public Notice of Availability for Review and Comments**



## **CITY OF GAINESVILLE**

Substantial Amendments to 2018-2022 Consolidated Plan, 2018-2022 Citizen Participation Plan, and 2019-2020 Annual Action Plan; Reallocation of 2019-2020 Community Development Block Grant (CDBG) Funds; and Allocation of CDBG-CV Funds

To respond to the Coronavirus Crisis and the impacts of social distancing, the City of Gainesville (City) proposes substantial amendments to the: 2018-2022 Consolidated Plan, 2018-2022 Citizen Participation Plan, and 2019-2020 Annual Action Plan. The proposed amendments will modify priority needs and strategic plan goals to reflect the inclusion of the following initiatives:

- **GNVCares About Businesses:** Economic development, including a small business grant and loan programs targeted to serve Low- and Moderate-Income and Community Reinvestment Areas;
- **GNVCares About Neighbors:** Expanded Public Services that may include public health, housing, community and economic development to prevent, prepare for, and respond to the Coronavirus.

This is a Substantial amendment because the City is re-allocating funds from previous CDBG program years and has received a new allocation of CDBG funds from the federal CARES Act, referred to hereafter as CDBG-CV. The following funds will be re-allocated and allocated to support the new GNVCares About Business and GNVCares About Neighbors designed to focus the City's COVID-19 relief and recovery activities:

- \$800,608 in Community Development Block Grant COVID-19 funds (CDBG-CV); and
- \$437,170 in 2019-2020 CDBG funds being re-programmed from activities that cannot be undertaken based on the mandated social-distancing and shelter-in-place. Funds may be re-programmed for the use of providing public health, housing, and community and economic development services to prevent, prepare for, and respond to the Coronavirus.

The City of Gainesville is also updating its Citizen Participation Plan to provide opportunities for the public to continue to participate in a public comment process virtually; and during a shortened regulatory advertisement, public comment, and virtual hearing timeframe.

Based on the regulatory relief provided in the CARES Act and guidance from the U.S. Department of Housing and Urban Development, the public will have five (5) days from publication of this advertisement to provide written comments.
