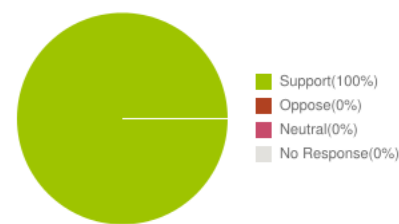

Overall Sentiment



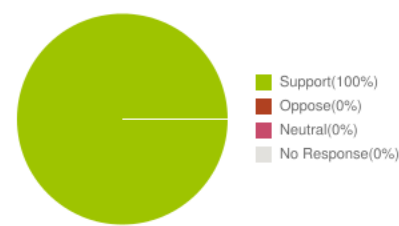

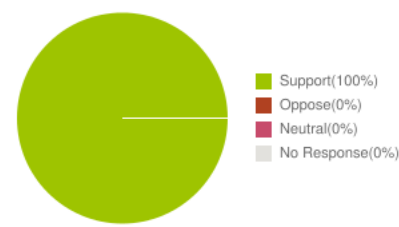

Hello Neighbors,

The City Charter Review Commission has completed their review of the City Charter and is hosting Public Hearings to get community feedback. Please see email below.

Of interest to FRHH residents is the elimination of Article V, 5.06: Funds for construction of paved surfaces in designated areas.

This section states "The City of Gainesville, Florida shall not expand, use, seek, permit, or allow the use of any city, county, state, private or federal funds for the construction of any paved surfaces for trails or transportation corridors on City-owned land designated as Conservation, as shown on the map dated May 1998 and on file in the Office of the Clerk of the Commission, within the Hogtown Creek Watershed. This provision is not intended to restrict paving for parking or recreational facilities constructed on land designated as Recreation on the aforementioned map.

(Ord. No. 041138, Sec. 1, 1-9-06)

Editor's Note- The above provision was a citizen initiative approved by the voters at the city regular election on March 17, 1998. It was included herein as Sec. 5.06 with the city's approval."

While the wording of this provision/amendment relates to funding for paved areas, the purpose was to prevent paving of the trail adjacent to Hogtown Creek. The City Commission at that time was planning to cut down large areas of trees and vegetation to pave what was termed a "transportation corridor" large enough for trucks from the Loblolly area on NW 34th Street just north of University Avenue through Ring Park. Environmentalists and residents believed this would have substantially disrupted the natural drainage that Hogtown Creek provides for the northwest side of Gainesville besides removing valuable

vegetation and wildlife habitats. The City Commission at that time rejected citizen concerns and a voter-initiated amendment to the City Charter was the only way to stop the development. Eliminating the provision/amendment will make paving that area possible. There may be other ways to protect Hogtown Creek but the Charter Review Commission did not identify any at the first public hearing.

Virtual Public Hearings Begin Tomorrow on Proposed Changes to City Charter

Gainesville, Fla. – In May 2019, the City of Gainesville formed a Charter Review Commission to review and propose changes to the City Charter. Beginning tomorrow, the commission will host three virtual public hearings to gather feedback from community members about the proposed charter amendments. Hearings are scheduled:

- Wednesday, April 15, 4-6 p.m.
- Thursday, April 23, 6-8 p.m.
- Thursday, April 30, 6-8 p.m.

The City Commission will have final approval before proposed amendments appear on the November 2020 ballot for voter consideration.

Opportunities for public participation will include:

Proposed charter amendments under consideration include:

1. Amend the charter to require that the City Commission "shall" have a Clerk. Will also re-title the "Clerk of the Commission" to "City Clerk."
2. Amend the charter to require that the City Commission "shall" have a City Attorney.
3. Amend the charter to require that the City Commission "shall" have an Internal Auditor.
4. Revise City Commissioner term limits from two 4-year consecutive terms to three 4-year consecutive terms.
5. Delete the section of the charter pertaining to having a general manager for GRU and amend the City Manager role to include the utilities powers and duties.
6. Increase signature requirements for voter initiated charter amendments from 10 percent to 20 percent of registered voters of the city.
7. Eliminate restrictions on use of funds for construction of paved surfaces in designated areas.
8. Increase salaries for the City Commission.
9. Further limit the authority of the City Commission to dispose of certain utility facilities.
10. Create a Preamble to the City Charter.

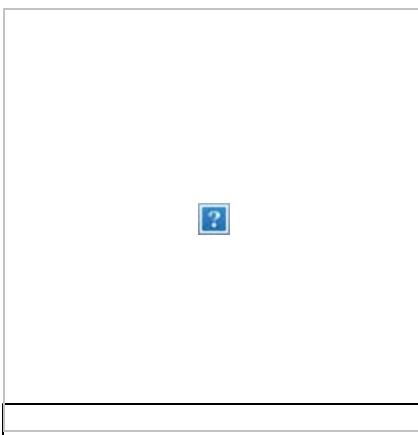
