These policies regulate placement of hazardous materials facilities within wellfield protection zones of the Murphree wellfield and require, at minimum, compliance with the Alachua County Hazardous Materials Management Code and the Alachua County Wellfield Protection Code. The application meets all requirements of the Murphree Wellfield Protection Code and appears consistent with design requirements in the Hazardous Materials Management Code. The proposed project should not endanger the city's water supply or environmental resources. There are no known wetlands, creeks, lakes, or sinkholes near the subject property. The property is not within a mapped strategic ecosystem area and does not contain any significant upland habitat or listed species habitat.
