WHY PURCHASE BODY CAMS FOR POLICE?

There are a number of case studies which reveal that wearing body cameras has proven to reduce: 1) officer use-of-force, 2) court overtime, 3) false complaints against officers. Bodyworn cameras also reduce the time officers spend doing manual report writing and paperwork, allowing them to get back into service with for efficiency.

- A year-long <u>study</u> on the benefits of body-worn cameras from the Las Vegas Metropolitan Police Department found a 37% reduction in use-of-force complaints against officers wearing body-worn cameras.
- A 2017 <u>study</u> by Queensland Police Service looked at the effects of BWCs being worn by officers responding to the scene of domestic and family violence incidents. The study found a 22% projected increase in reported assaults and a 60-70% decrease in police legal hearings.
- A year-long <u>study</u> by Cambridge University on the Rialto PD in California (more than 400 officers) studied the effects on use-of-force when officers wore Axon Flex cameras. The study found a drop in use-of-force incidents by 59% and a reduction in complaints of 87.5%.
- A <u>study</u> in The Journal of Law Enforcement found that body-worn cameras improve law enforcement officer report writing accuracy. In the study, officers completed their useof-force reports first by memory, then had the opportunity to review the body camera footage. An average of 2.63 minor errors, 5.4 moderate errors, and 0.9 major errors were **corrected** by officers' BWC review.
- A six-month long <u>study</u> on the Denver Police Department found officers were 34% less likely to receive a complaint involving inappropriate force when body-worn cameras were present.
