2 3 4 5 6 7 8 9	An ordinance of the City of Gainesville, Florida, amending the Land Development Code (Chapter 30 of the City of Gainesville Code of Ordinances) by amending accessory dwellings as a permitted use in certain zoning districts with associated regulations; by amending Section 30-2.1 <i>Definitions</i> ; by amending Section 30-4.12 <i>Permitted Uses in Transects</i> ; by amending Section 30-4.16 <i>Permitted Uses in Residential Districts</i> ; by amending Section 30-4.19 <i>Permitted Uses in Mixed-Use and Nonresidential Districts</i> ; by amending Section 30-4.23 <i>Permitted Uses in Special Districts</i> ; by amending Section 30-5.35 <i>Accessory dwellings</i> ; providing directions to the codifier; providing a severability clause; providing a repealing clause; and providing an effective date.
11	WHEREAS, the Municipal Home Rule Powers Act, Chapter 166, Florida Statutes, secures for
12	municipalities the broad exercise of home rule powers granted by Article VIII, Section 2 of the Florida
13	Constitution, including the exercise of any power for municipal purposes not expressly prohibited by
14	law; and
15	WHEREAS, Sections 163.3167 and 163.3177(1), Florida Statutes, requires the City of Gainesville to
16	maintain a Comprehensive Plan to guide the future development and growth of the city by providing
17	the principles, guidelines, standards, and strategies for the orderly and balanced future economic,
18	social, physical, environmental and fiscal development of the city; and
19	WHEREAS, the City of Gainesville is required by Section 163.3202, Florida Statutes, to adopt or amend
20	and enforce land development regulations that are consistent with and implement the Comprehensive
21	Plan, and that are combined and compiled into a single land development code for the city (the City of
22	Gainesville's Land Development Code is Chapter 30 of the Code of Ordinances); and
23	WHEREAS, this ordinance, which was noticed as required by law, will amend the text of the Land

- 1 WHEREAS, the City Plan Board, which acts pursuant to the authority granted in Section 4.02 of the
- 2 Charter Laws of the City of Gainesville and which acts as the Local Planning Agency pursuant to Section
- 3 163.3174, Florida Statutes, held a public hearing on February 27, 2020, and voted to recommend that
- 4 the City Commission approve this text amendment to the Land Development Code; and
- 5 WHEREAS, an advertisement no less than two columns wide by ten inches long was placed in a
- 6 newspaper of general circulation and provided the public with at least seven days' advance notice of
- 7 this ordinance's first public hearing to be held by the City Commission; and
- 8 WHEREAS, a second advertisement no less than two columns wide by ten inches long was placed in
- 9 the aforesaid newspaper and provided the public with at least five days' advance notice of this
- ordinance's second public hearing to be held by the City Commission; and
- 11 WHEREAS, public hearings were held pursuant to the notice described above at which hearings the
- 12 parties in interest and all others had an opportunity to be and were, in fact, heard; and
- 13 WHEREAS, the City Commission finds that the Land Development Code text amendment described
- herein is consistent with the City of Gainesville Comprehensive Plan.
- 15 NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE,
- 16 **FLORIDA**:
- 17 **SECTION 1.** Section 30-2.1 of the Land Development Code is amended as follows. Except as amended
- 18 herein, the remainder of Section 30-2.1 remains in full force and effect.

19 Section 30-2.1. Definitions.

- 21 Accessory dwelling unit means a subordinate living unit added to, created within, or detached from a
- 22 single-family dwelling (but within the same lot) that provides basic requirements for independent
- 23 living, sleeping, eating, cooking and sanitation. (ADU) means an independent self-contained dwelling

- unit with kitchen and bathroom facilities, on the same lot as an associated primary use or structure.
- 2 An ADU may be within, attached to, or detached from a primary structure.

- 5 **SECTION 2.** Section 30-4.12 of the Land Development Code is amended as follows. Except as amended
- 6 herein, the remainder of Section 30-4.12 remains in full force and effect.

Section 30-4.12. Permitted Uses.

- 8 The following table contains the list of uses allowed, and specifies whether the uses are allowed by right (P),
- 9 accessory to a principal use (A), or by special use permit approval (S). Blank cells indicate that the use is not
- allowed. No variances from the requirements of this section are allowed.

- 18 **SECTION 6.** Section 30-5.35 of the Land Development Code is amended as follows.
- 19 Section 30-5.35. Accessory dwellings dwelling units (ADUs).
- 20 Accessory dwelling units are allowed in certain districts as specified in article IV and only in
- 21 conjunction with a primary single family dwelling unit. Only one accessory dwelling unit may be
- 22 permitted per lot or parcel.
- 23 A. Location. An accessory dwelling unit may be attached or detached from the principal building.
- 24 B. Style. The accessory dwelling unit shall be designed as a subordinate structure to the primary
- 25 structure on the lot in terms of its mass, size and architectural character. The architectural design,
- 26 character, style and appearance of the accessory unit shall be consistent and compatible with the
- 27 primary structure.
- 28 C. Parking and access.

- Off street parking for the accessory dwelling, if provided, shall be located on the lot on which
 the principal building is located.
 - An accessory dwelling unit and any off street parking spaces shall be served by the same driveway as the principal building.
- 5. Standards. Each accessory dwelling unit shall comply with all standards applicable within the
 6 zoning district, including required setbacks and building height limits. Accessory dwelling units are
 7 exempt from residential density calculations.
- 8 E. Owner occupancy required. Property owner residency, as shown by an existing homestead 9 exemption, in either the primary or accessory dwelling unit shall be a requirement for permitting 10 of accessory dwelling units.
- F. Building size. The living area of the unit shall be a maximum of 50 percent of the principal residence or 1,000 square feet, whichever is lesser.
- 13 G. Subdivision. An accessory unit may not be sold separately unless properly subdivided in accordance with this chapter.
- 15 A. Purpose.

- Provide homeowners property owners with flexibility in establishing separate living quarters
 within or adjacent to their homes for purposes such as caring for seniors, providing housing for their children, or obtaining rental income.
- 19 <u>2. Increase the range of housing choices and the supply of accessible and affordable housing</u>
 20 <u>units within the community.</u>
- 21 3. Ensure that the development of ADUs meets neighborhood design standards. does not cause
 22 negative impacts on the character or stability of single-family neighborhoods.
- 23 B. Standards.
- One attached ADU and one detached ADU Only one ADU may be permitted per lot or parcel,
 and ADUs are exempt from residential density calculations.
- 2. Each ADU must comply with all standards applicable within the zoning district, including
 required setbacks and building height limits.
- 28 <u>3. A non-conforming accessory structure converted to an ADU must meet the requirements of</u> 29 Section 30-10.4.
- 4. An ADU may not exceed two stories. ADUs must meet accessory structure setbacks. If an ADU exceeds a single story, the applicant shall take measures to ensure the privacy of neighbors, including orienting windows and outdoor balconies to face internally into the lot and away from neighboring residences.

1	45. Each allowed ADU₅, either attached or detached, may not exceed 850 square feet or up to
2	50% of the size of the primary structure (not including the garage and unconditioned space),
3	whichever is less. Structures exceeding 850 square feet that existed on February 27, 2020,
4	may be converted into ADUs.
5	5€. ADUs must be designed as a subordinate structure to the primary structure on the lot in
6	terms of its mass, size, height, and architectural character. The architectural design,
7	character, style, and appearance of the ADU must be consistent and compatible with the
8	primary structure.
9	67. New detached ADUs or ADUs extending from existing structures may not comprise more than
10	50% of the total visible façade area parallel to the front property line.
11	8. One parking space per ADU must be provided in addition to any required parking for the
12	primary unit. However, on-street parking where available may be used to meet ADU parking
13	requirements. If off-street parking is provided, ADUs must be served by the same driveway as
14	the principal building.
15	79. Utilities. ADUs may share existing utility and service infrastructure with the primary unit,
16	subject to compliance with GRU standards.
17	<u>8</u> 10 . Subdivision. An ADU may not be sold separately or as a condominium unless properly
18	subdivided in accordance with this chapter.
19	
20	
21	SECTION 7. It is the intent of the City Commission that the provisions of Sections 1 through 6 of this
22	ordinance become and be made a part of the Code of Ordinances of the City of Gainesville, Florida
23	and that the sections and paragraphs of the Code of Ordinances may be renumbered or relettered in
24	order to accomplish such intent.
25	SECTION 8. If any word, phrase, clause, paragraph, section, or provision of this ordinance or the
26	application hereof to any person or circumstance is held invalid or unconstitutional, such finding wil
27	not affect the other provisions or applications of this ordinance that can be given effect without the
28	invalid or unconstitutional provision or application, and to this end the provisions of this ordinance are
29	declared severable.

1	SECTION 9. All ordinances or parts of ordinances	in conflict herewith are to the extent of such conflict
2	hereby repealed.	
3	SECTION 10. This ordinance will become effective	ve immediately upon adoption.
