## **RESOLUTION NO. 200259**

**A Resolution of the City of Gainesville, Florida, accepting FAA AIP Grant No. 3-12-0028-045-2020 from the U.S. Department of Transportation, Federal Aviation Administration, and authorizing execution by the Mayor and the Clerk of the Commission on behalf of the City of Gainesville; and providing an immediate effective date.**

**WHEREAS**, On June 10, 2020, the Gainesville-Alachua County Regional Airport Authority (GACRAA) submitted a project application to the U.S. Department of Transportation, Federal Aviation Administration (FAA) seeking federal grant funds in the amount of up to \$1,796,715.00, representing 90% of the eligible project costs for the “Expand Terminal Building (2 Passenger Boarding Bridges) Project” (Project); and

**WHEREAS**, the FAA has submitted a Grant Agreement, which constitutes an offer to the City of Gainesville and GACRAA to be executed by the appropriate officials and which, when so accepted, will constitute a Grant Agreement by which the United States Government will participate in the allowable costs of the Project with the federal share to be estimated up to \$1,796,715.00 or 90% of eligible project costs; and

**WHEREAS**, the FAA requires that the City of Gainesville and GACRAA both accept the grant offer prior to receiving federal grant funds; and

**WHEREAS**, on June 25, 2020, GACRAA adopted Resolution No. 20-008, which accepted and authorized execution of the anticipated grant offer and authorized the Airport’s Chief Executive Officer to prioritize and negotiate with the FAA any needed reductions in the Project scope of work to match the available federal funding; and

**WHEREAS**, Gainesville Regional Airport staff has requested that the City of Gainesville approve the anticipated grant offer subject to final approval by GACRAA and timely review by the City Attorney.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:**

**Section 1.** Upon award of the grant offer from the FAA, the City of Gainesville shall accept and enter into Grant Agreement No. 3-12-0028-045-2020 for the purpose of obtaining federal aid in the development and operation of the Gainesville Regional Airport, which is to be implemented, constructed, and operated by GACRAA in accordance with Chapter 2006-363, Laws of Florida.

**Section 2.** The City of Gainesville does hereby ratify and adopt all statements, representations, warranties, covenants, and agreements contained in and incorporated into FAA Grant Agreement No. 3-12-0028-045-2020, and by such acceptance, and in

reliance upon the assurances of GACRAA's Chief Executive Officer that GACRAA agrees to abide by all of the terms and conditions of said Grant Agreement and the assurances made by GACRAA in Resolution No. 20-008, does agree to all of the terms and conditions thereof.

**Section 3.** Lauren Poe, Mayor, is hereby authorized and directed to execute said Grant Agreement No. 3-12-0028-045-2020 on behalf of the City of Gainesville in the amount of \$1,796,715.00 or at any lesser amount offered by the FAA with a corresponding reduction in the scope of work and related costs as itemized in the Project application dated June 10, 2020, and Omichele D. Gainey, Clerk of the Commission, is hereby authorized and directed to impress the official seal of the City of Gainesville and to attest to said execution.

**Section 4.** This resolution shall take effect immediately upon adoption.
