RESOLUTION NO. 200315 1 2 3 4 5 A resolution of the City Commission of the City of 6 Gainesville, Florida; relating to the levy of general 7 municipal purpose Ad Valorem Taxes for the 2020-2021 8 fiscal year beginning October 1, 2020 and ending 9 September 30, 2021; adopting the Final Millage Rate; 10 directing the transmittal of certified copies; authorizing a 11 specified adjustment to the final millage rate; and 12 providing an immediate effective date. 13 14 15 WHEREAS, July 16, 2020, the City Commission of the City of Gainesville, Florida 16 adopted Resolution No. 200061, which approved a Proposed Tentative General Government 17 Financial and Operating Plan budget for the City of Gainesville, Florida; and 18 19 WHEREAS, on July 16, 2020, the City Commission adopted Resolution No. 200062 approving the proposed millage rate necessary to fund the Proposed Tentative General 20 Government Financial and Operating Plan budget; and 21 WHEREAS, pursuant to law and utilizing the rate established in Resolution No. 200062, 22 on or about August 16, 2020, the Alachua County Property Appraiser mailed a Notice of Proposed 23 Property Taxes to each taxpayer listed on the current year's assessment roll; and 24 WHEREAS, the said Notice of Proposed Property Taxes advised the recipients of the 25 public hearing to be conducted by the City Commission for consideration of its Tentative General 26 Government Financial and Operating Plan Budget and the Tentative Millage necessary to fund the 27

specified in the Notice of Proposed Property Taxes and in accordance with applicable law; and

WHEREAS, on September 10, 2020, the City Commission held the public hearing as

WHEREAS, on September 10, 2020, the City Commission of the City of Gainesville, FL adopted Resolution No. 200258 approving a Tentative Millage Rate necessary to fund the Tentative General Government Financial and Operating Plan Budget;

- 5 NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY
- **OF GAINESVILLE, FLORIDA:**
- Section 1. The final operating millage rate of 5.2974 mills to fund the Final General
 Government Financial and Operating Plan Budget for the City of Gainesville's 2020-2021 fiscal
 year is approved.
- Section 2. The General Fund final operating millage rate approved herein is greater than the rolled-back rate of 5.0237 mills by 5.45%.
 - Section 3. The City Manager is hereby authorized and directed to transmit copies of this Resolution, as well as any other forms or documents required by law, to the Alachua County Property Appraiser, Alachua County Tax Collector, and the Florida Dept. of Revenue within three (3) days after the adoption of this Resolution.
 - Section 4. In the event the City is notified by the Alachua County Property Appraiser of an aggregate change in the assessment roll of more than one (1) percent pursuant to Section 200.065(6), Florida Statutes, then the millage rate adopted in Section 1 of this Resolution may be adjusted in accordance with Section 200.065(6), Florida Statutes. The City Manager is hereby authorized to compute the adjustments as provided in Section 200.065(6) and administratively adjust the millage rates. The City Manager is also authorized and directed to execute an official notification of the millage adjustment and shall deliver the same to the Alachua County Property Appraiser within three (3) days of the receipt of any notice of aggregate change in the assessment roll.
