Statement of the Problem:

Gainesville is the largest city and the county seat of Alachua County. The city has a population over 125,000 residents and the University of Florida, a nationally top-ranked university, attracts over 50,000 students and their families every year. Gainesville receives a large number of visitors during collegiate and national sporting events. Each year, more than 100,000 people flood the city for the NHRA drag race, Gatornationals and tens of thousands of fans flock to Florida Field to watch the University of Florida Gators play football.

Department of Transportation 2021 Highway Safety Matrix ranks Gainesville 5th of 33 cities with population of 75,000 and above for Distracted Driving. In 2018, of the 5,089 crashes within the city limits and 1,297 of those crashes showed that the driver was distracted. In 2019, of the 6,070 crashes in Gainesville, 1,259 were contributed to distracted driving.

- * Gainesville also saw nearly a 20% increase in distracted driving related crashes from 2017 to 2018 and 19.28% increase from 2018 to 2019.
- *Information gathered from Florida's Integrated Report Exchange System (FIRES) and Signal 4 Analytics.

Proposed Solution:

The Gainesville Police Department is committed to taking every action to continue to drive down crashes and fatalities associated with distracted driving. The City of Gainesville in partnership with GPD and other City Departments to work toward Vision Zero using enforcement, education, engineering and evaluation. Gainesville PD will conduct high visibility enforcement overtime details to target and educate those individuals that are driving distracted. GPD also plans to partner with local businesses to offer rewards or incentives for individuals who are observed not driving distracted in an effort to use positive reinforcement to gain compliance. Patrol and high visibilty enforcment operations will also be deployed to areas where crashes are most preveleant. Operations will be conducted at least twice quarterly with at least two of the details commencing during the nighttime hours of 7:00 pm to 4:00 am

GPD will use Fatal Vision Distracted Driving goggles and education kit. These goggles and kit will be utilitzed for educational purposes during community meetings, high school and university educational demos, GPD and City of Gaineville sponsored Citizen Academys. These educational sessions will be conducted at least once a quarter.

On a monthly basis, Gainesville PD will utilize social media networking tools, including but not limited to Facebook and Twitter to raise awareness of the importance of not allowing distractions while driving. In addition, the department will partner with local resources such as the Community Traffic Safety Teams, School Resource Officers, the Florida Law Enforcement Liaison Local Area Network, community organizations and local media outlets promote safe, undistracted driving.

Printed education materials will be distributed during enforcement and educational operations. These materials will be sourced from agencies and organizations including, but not limited to, the National Safety

Council, NHTSA, FDOT and the Center for Disease Control and Injury.

Sustainability:

The Gainesville Police Department remains committed to reducing the number of crashes, fatalities, injuries and severity of injuries on the highways, streets and roadways. Gainesville PD will continue to have a full-time traffic unit, including a DUI/DRE specialist to enforce traffic laws within the city limits of Gainesville. Our agency, without funding, will still conduct distracted driving enforcement and make a positive contribution on safe driving.

The Gainesville Police Department will continue to partner with local resources such as Community Traffic Safety Teams, the Florida Department of Transportation Law Enforcement Liaison, community organizations and local media outlets. The Gainesville Police Department will also participate in all statewide public awareness and enforcement campaigns and law enforcement challenges sponsored by the FDOT Safety Office.

Project Objectives:

With the stated goal in mind, the Gainesville Police Department will work toward the following objectives:

Reduce traffic crashes by 2%,

Reduce injuries in traffic crashes by 2%,

Utilize social media networking tools to raise awareness to the Public about the dangers of distracted driving,

Provide printed education materials for distribution,

Develop a "Top 5" list of high crash and or fatality locations and conduct enforcement deployments at these problem locations.

Evaluation:

The success of this project will be measured by:

The number of motor vehicle crashes in the City of Gainesville is reduced by at least 2% when compared to the previous three year average.

A 2% reduction of the number of distracted driving related fatalities and injuries in the City of Gainesville when compared to the previous three year average.

The number of high visibility distracted driving overtime enforcement operations conducted.

The number of high visibility distracted driving overtime enforcement operations conducted during nighttime hours (7:00 pm to 4:00 am).
