Discussion of Commercial and Multifamily Recycling in Gainesville (B)

A presentation on the commercial waste stream was made by Thomas Strickland, Recycling Coordinator. Steven Joplin, Solid Waste Manager, Michael Heimbach, Sustainability Manager, and Phil Mann, Assistant City Manager also spoke to the item.

Direction was given to staff to come back at the January 5 meeting with detailed policy points for changes in the commercial recycling ordinance. Including expanding the definition of what commercial businesses should be required to recycle, creating parameters on capacity for multifamily recycling and providing for education and signage to residents.

Staff will also check on the termination date of the school board waste contract. Phil Mann will invite representatives from Communications, Marketing and Sustainable Development to future subcommittee meetings.
