In accordance with the Interlocal Agreement for Public School Facility Planning, the Alachua County Public School's Superintendent Simon requests your involvement in an upcoming School Planning Advisory Committee meeting. The Interlocal Agreement establishes procedures for coordination between local governments and the School Board of Alachua County.
