### **AHAC Orientation**

#### **General Definition**

- Affordable Housing
- Affordable to households with low incomes
  - Not "rich or wealthy people"
  - Usually 80% (or less) of the average for the County

#### SHIP Purpose

- Created in 1992 by the State Legislature
  - Partnership between real estate development industry & affordable housing advocates
  - Encourage construction of new affordable housing
  - Encourage repair of existing affordable housing
  - Encourage affordable home ownership
- Governed by State Statutes
  - Can be changed by the Legislature

### SHIP-Revenue Source & Program Gainesville

- Revenue source is tax on real estate sales
  - Revenues increase as prices (need) increase
  - Revenue is generated by real estate development industry
  - Result: much of the legislation is focused on land development regulations
- Program
  - State programs (like SAIL) that fund large affordable rental housing projects
  - Local programs with funds redistributed to all Counties and some Cities



#### **SHIP-Local Programs**

- At least 75% of funds on new construction or rehabilitation (repair)
- At least 65% of funds on homeownership activities
  - Like Down Payment Assistance, and Homeowner Repair
- No more than 10% for administration
- Many other plans, reports and requirements

#### **AHAC**

# Gaines ville

- To receive SHIP Funds, the State requires the City Commission to appoint an AHAC
- The State governs the composition of AHAC
  - Representation from diverse stakeholder groups
  - Including 1 City Commissioner
    - Must attend 2 training workshops/year
  - Section 420.9076(2) of the Florida Statutes
- State mandates that AHAC develop and submit an Incentives and Recommendations Report (IRR) each year
  - This is identified as AHAC's primary purpose

#### **AHAC-IRR**

- Review all City plans, policies, procedures, processes, rules, ordinances, regulations, codes and incentives
- 11 items are specifically called out for review
  - Two are required to be implemented
    - Review of new regulations
    - Expedited review of affordable housing projects
  - Section 420.9076(4) of the Florida Statutes
- Recommend actions to increase access to affordable housing
- To receive SHIP funds
  - City Commission must accept the IRR; and
  - Authorize submitting it to the State

#### **AHAC-Other Duties**

- AHAC may perform other duties requested by the Local Government
- Generally, this has included:
  - Review and recommendation of projects requesting a financial match for LIHTC or SAIL affordable rental housing projects
    - These recommendations go to the City Commission or the City Manager
  - Review and comment on other plans with an affordable housing component

#### **HCD Division**

- Provide comprehensive housing and public services programs designed to improve the quality of life for income eligible neighbors in the City of Gainesville
- Administers programs and funds from several sources
  - Federal (CDBG & HOME)
  - State (SHIP)
  - Local (ConnectFree)
  - All plans, reports, applications, payments, advisory boards, & public engagement

#### **Housing Programs**

- Home Repair
- Home Replacement
- Down Payment Assistance
- Mortgage Foreclosure Intervention
- Housing Counseling & Training
- Rental Assistance
- Public Services by Nonprofit Organizations

#### **Housing Programs (continued)**

- Provides financial assistance to connect existing homes to GRU water & wastewater services
- Create and strengthen public/private partnerships to develop new affordable housing:
  - Single-Family Housing:
    - Nonprofit affordable housing developers (i.e., AHFH, NHDC, GHDMC)
    - Heartwood Subdivision
    - Duval Land Donation Pilot Program
  - Rental Housing: Deer Creek, Royal Park, Woodland Park-Ph.1, Arbours at Tumblin Creek

#### **HCD-Other Duties**

Gainesville

- Housing Action Plan
  - Administer the Consultant Contract
  - Additional public engagement
  - Plan Implementation after adoption
- Homelessness Initiatives
  - Empowerment Center and Cold Night Shelter
- Other special projects
  - Neighborhood Narratives
  - Coronavirus Relief Fund (Housing and Utility Assistance Program)
  - Federal Cares Act (GNVCares)
  - FEMA (hurricanes)
