# 200920. Overview of Incentives and Recommendations Report

Mr. Wachtel gave a presentation that included a general definition of "affordable housing," a brief review of the State Housing Initiatives Partnership (SHIP) Program, a brief review of the City's programs, a description of the Incentives and Recommendations Report (IRR), a proposed IRR schedule, a description of public engagement measures for the IRR, and a description of the required elements of the IRR, including other possible incentives/initiatives.

Ms. Bell suggested that the Committee also consider incentives for mixed-use, not just affordable housing, within developments.

Ms. Hildreth suggested that the Committee explore the similarities and differences between City and County incentives and regulations. In addition, she thought that an online survey could be helpful.

Mr. Basu-Dutta noted that in September, he might not be available.
