OF RESOLUTION AUTHORIZING ACCEPTIANCE AN **AIRPORTS** CORONAVIRUS REPONSE GRANT PROGRAM (ACRGP) GRANT # 3-12-0028-046-2021 FROM THE U.S. DEPARTMENT OF TRANSPORTATION, ADMINISTRATION, FEDERAL **AVIATION** ON **BEHALF** OF THE GAINESVILLE-ALACHUA COUNTY REGIONAL AIRPORT AUTHORITY

WHEREAS, on December 27, 2020, President Donald J. Trump signed into law the Coronavirus Response and Relief Supplemental Appropriation Act (Public Law 116-260) which includes approximately \$1.75 billion in Airports Coronavirus Response Grant Program (ACRGP) funds to be awarded as economic relief to eligible U.S. airports, affected by the prevention of, preparation for, and response to the COVID-19 pandemic, including support for continuing airport operations; and

WHEREAS, FAA ACRGP funds may be used for any purpose for which airport funds may be lawfully used, as found in the Office of Airports Revenue Use Policy; and

WHEREAS, FAA ACRGP funds do not require a local match; and

**WHEREAS**, the Federal Aviation Administration has made a ACRGP Grant Offer in the amount of \$2,293,744; and

**WHEREAS,** the Grant Offer made by the USDOT Federal Aviation Administration will also be presented to the co-sponsor, the City of Gainesville, for approval and legal review;

## NOW, THEREFORE,

## BE IT RESOLVED BY THE GAINESVILLE-ALACHUA COUNTY REGIONAL AIRPORT AUTHORITY, as follows:

Section 1. That the Gainesville-Alachua County Regional Airport Authority accepts said Grant Offer from FAA ACRGP funding in the amount of \$2,293,744.

Section 2. The Gainesville-Alachua County Regional Airport Authority, being familiar with the terms of said Grant Offer, does hereby ratify and adopt all statements, representations, warranties, covenants, and agreements contained in said Offer, and by such acceptance, agree to abide by all of the terms and conditions of the Grant Agreement.

Section 3. That the Gainesville-Alachua County Regional Airport Authority hereby authorizes Allan J. Penksa, Chief Executive Officer, to accept the FAA ACRGP Grant Agreement offer # 3-12-0028-46-2021 from the USDOT, subject to review by the Attorney for the Authority, and to fully execute and sign such documents as may be necessary.
