RESOLUTION AUTHORIZING **ACCEPTIANCE** OF AN **AIRPORTS** CORONAVIRUS RESPONSE GRANT PROGRAM (ACRGP) ADDENDUM TO GRANT 3-12-0028-046-2021 FROM THE U.S. **DEPARTMENT** TRANSPORTATION, FEDERAL AVIATION ADMINISTRATION, ON BEHALF THE GAINESVILLE-ALACHUA COUNTY REGIONAL AIRPORT **AUTHORITY**

WHEREAS, on December 27, 2020, President Donald J. Trump signed into law the Coronavirus Response and Relief Supplemental Appropriation Act (Public Law 116-260) which includes nearly \$200 million in Airports Coronavirus Response Grant Program (ACRGP) funds to be awarded as economic relief to eligible U.S. airports to provide relief from rent and minimum annual guarantees to on-airport car rental, on-airport parking, and in-terminal airport concessions; and

WHEREAS, FAA ACRGP concession relief funds are to be provided to each airport concession based on its proportional share of the total annual rent and minimum annual guarantees for the airport; and

WHEREAS, FAA ACRGP funds do not require a local match; and

WHEREAS, the Federal Aviation Administration has made a Grant Offer as an addendum to Grant Offer # 3-12-0028-46-2021 in the amount of \$58,524 for concession relief; and

WHEREAS, the grant offer made by the USDOT Federal Aviation Administration will also be presented to the co-sponsor, the City of Gainesville, for approval and legal review;

NOW, THEREFORE,

BE IT RESOLVED BY THE GAINESVILLE-ALACHUA COUNTY REGIONAL AIRPORT AUTHORITY, as follows:

Section 1. That the Gainesville-Alachua County Regional Airport Authority accepts said Grant Offer # 3-12-0028-047-2021 FAA ACRGP funding in the amount of \$58,524.

Section 2. The Gainesville-Alachua County Regional Airport Authority, being familiar with the terms of said Grant Offer, does hereby ratify and adopt all statements, representations, warranties, covenants, and agreements contained in said Offer, and by such acceptance, agree to abide by all of the terms and conditions of the Grant Agreement.

Section 3. That the Gainesville-Alachua County Regional Airport Authority hereby authorizes Allan J. Penksa, Chief Executive Officer, to accept the FAA ACRGP Grant Agreement offer # 3-12-0028-047-2021, a concessions addendum to grant offer # 3-12-0028-046-2021, from the USDOT, subject to review by the Attorney for the Authority, and to fully execute and sign such documents as may be necessary.
