RESOLUTION NO. 201170

A Resolution of the City of Gainesville, Florida, accepting FAA Airports Coronavirus Response Grant Program Grant No. 3-12-0028-047-2021 from the U.S. Department of Transportation, Federal Aviation Administration, and authorizing execution by the Mayor and the Clerk of the Commission on behalf of the City of Gainesville; and providing an immediate effective date.

WHEREAS, On February 16, 2021, the Gainesville-Alachua County Regional Airport Authority (GACRAA) submitted an Airports Coronavirus Response Grant Program Grant Application to the Department of Transportation, Federal Aviation Administration (FAA) seeking federal funds in the amount of up to \$58,524; and

WHEREAS, the FAA submitted a Grant Agreement, which constitutes an offer to the City of Gainesville and the GACRAA to be executed by the appropriate officials which, when so accepted, will constitute a Grant Agreement for \$58,524; and

WHEREAS, the FAA requires that the City of Gainesville and the GACRAA both approve and accept the grant offer prior to receiving federal grant funds; and

WHEREAS, on April 22, 2021, the GACRAA adopted Resolution 21-017, which accepted and authorized execution of the anticipated grant offer and authorized the Airport's Chief Executive Officer to execute the grant offer; and

WHEREAS, Gainesville Regional Airport staff has requested that the City of Gainesville approve the grant offer subject to final approval by GACRAA and timely review by the City Attorney.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA:

Section 1. The City of Gainesville shall accept and enter into Grant Agreement 3-12-0028-047-2021, for the purpose of obtaining federal aid in the operation of the Gainesville Regional Airport under Grant Agreement 3-12-0028-047-2021 that is to be implemented and operated by the GACRAA in accordance with Chapter 2006-363, Laws of Florida.

Section 2. The City of Gainesville does hereby ratify and adopt all statements, representations, warranties, covenants, and agreements contained in FAA Grant Agreement 3-12-0028-047-2021, and incorporated material referred to in the said Grant Agreement, and by such acceptance, and in reliance upon the assurances of GACRAA's Chief Executive Officer that the GACRAA agrees to abide by all of the terms and

conditions of said Grant Agreement and the assurances made by GACRAA in Resolution No. 21-017, does agree to all of the terms and conditions thereof.

Section 3. Lauren Poe, Mayor, is hereby authorized and directed to execute said Grant Agreement 3-12-0028-047-2021 on behalf of the City of Gainesville in the amount of \$58,524 and Omichele Gainey, City Clerk is hereby authorized and directed to impress the official seal of the City of Gainesville and to attest to said execution.

Section 4. This resolution shall take effect immediately upon adoption.
