IV. Chair Report

Jon attended the monthly Advisory Board Chairs meeting with Interim Director Roxana Gonzalez. Ms. Gonzalez gave a budget request update and noted that she is advocating for requesting a full-time Recreation Leader for Sweetwater Wetlands Park. Geoff Parks, Nature Operations Supervisor, last day of employment was April 29th. The City's Strategic Plan is in the works. PRCA is waiting to update the Master Plan and see where they coincide.

V. Treasurer's Report

\$5,523 balance, same as last time. Purchase of large screen television with mount for new nature center approved in April will be reflected in next month's budget report.

April monthly report was distributed to all members.

Penny Weber generously donated three pairs of binoculars.

Linda reported on a few of the highlights which included a staffing update, and reported on a prescribed burn at Morningside which spotted over to another unit and burned an additional 20 acres for a total of 26 acres.

- c. PRCA WSPP Working Group Mike and Penny attended April 14th meeting. Betsy Waite commented on improvements at NE and McPherson parks. 2021 project list includes Boulware Park renovation, Loblolly boardwalk, Ring Park and Duvai Park signage. There was also discussion on the County's efforts to extend the Wild Spaces and Public Places program which is funded by a half-cent sales tax.
- IX. Friends of Nature Parks Report Penny sent a handout describing Morningside's Earth Academy Day Camp outline for five weeks of summer camp. Two students received scholarships for 4 sessions, met with them and their families, approved. Next FoNP meeting June 6th.

X. Old Business

a. "Wish List" - There was discussion of putting the "Wish list" into annual retreat agenda. After discussion of annual retreat format, Leslie returned to discussion of "wish list" expenditures. Having summed projected costs in the written list that was presented at the April NCC meeting, and subtracting totals from NCC finances, leaving surplus of \$1,188, Leslie moved to propose approval of the list's expenses. No one seconded and discussion continued. Jon said the fiscal year starts in October. Grace asked if anyone objected to any expenditures. Leslie pointed out that if the monies were not used, they would be lost. Marilyn said someone had offered to donate school supplies. Michael asked if Natural Resource Management staff had any requests. Linda said none had been made. Jon read the written list aloud and summarized expenses which included trail maps for Sweetwater Wetlands Park. Marilyn seconded Leslie's motion, unanimous vote to approve "wish list" expenditures.

2018-2019 Accomplishments 2018/19 FY Workplan

- 1. NCC provided a liaison to the WSPP oversight committee. NCC discussed recent developments in possible use of WSPP funds. NCC continued to advocate for improved progress on deferred maintenance issues, and nature parks needs, and provided input on 2 year work plan.
- 2. NCC and its members continued to provide information to educate City Commission on history, extent, and provisions of the master plan and vision 2020.
- 3. NCC approved expenditure of its funds for several purchases to support Environmental Education programs and improve visitor comfort and information at parks such as interpretive materials, maps, picture identification cards of flora and fauna, and water stations.
- 4. NCC presented STAR awards to 5 good neighbors and 1 volunteer group to acknowledge their contributions to nature parks and environmental awareness in the City.
- 5. NCC continued to provide input to staff on acquisitions, improvements, and management.
- 6. NCC continued to work with staff to identify and resolve issues of access, signage, public safety, and vandalism in nature parks.
- 7. NCC provided input on draft city park design standards and wayfinding guidelines
- 8. Poetry in parks
- 9. NCC initiated regular publicly noticed site visits to city parks

2019/20 FY Workplan

On-going Activities of Nature Center Commission

- 1. Support environmental programs and other outreach activities at Morningside, Sweetwater Wetlands, and in-school programs such as Kids in the Woods and Friends of Nature Parks' poetry competition.
- 2. Advocate and promote family/parent-child participation and visitation to nature parks and programs.
- 3. Work with academic collaborators to evaluate current/historic participation in parks/programs through trail counters, surveys, and program data. This will include addressing recreation, management, and utilization plans.
- 4. Support Friends of Nature Parks activities.
- 5. Review and approve land management plans as needed.
- 6. Maintain liaisons with other citizen committees, advisory boards, and agencies such as the Tree Advisory Board, Bicycle/Pedestrian Board, ROSCO, City Beautification Board, and Florida Forest Service, as well as university strategic planners.
- 7. Collaborate with staff on implementing nature-related WSPP projects and advocating for nature park improvements in accordance with the Master Plan.
- 8. Continue monthly site visits.

Policy Committee Initiatives

- 9. Work with staff to develop policies for appropriate access to city's nature parks and conservation areas as well as for responsible and appropriate types and levels of use of these areas for the public in accordance with city staff and WSPP funding, policies, and standards. Advise the City Commission regarding appropriate funding to accomplish access and use, including signage.
- 10. Review and make recommendations on grant applications and land acquisitions.
- 11. Review city codes and policies that protect and maintain the integrity of our tree canopy, parks, and conservation lands.
- 12. Liaise with city staff through GAP Foundation to obtain additional PRCA department-wide funding that is consistent with the Master Plan.

Public Relations Committee Initiatives

- 13. Develop, enhance, track, and monitor tools for environmental education, outreach, and advertising events.
- a) Large storyboard, small table-top, and interactive electronic displays
- b) Radio commercials, PSAs, newspaper articles, posters, social media, and other forms of advertisement.
- c) Cooperation with partner organizations; participation of board members where feasible.
- d) Update short descriptions of parks in promotional materials as needed, including for the new Friends of Nature Parks website.
