**PUBLIC COMMENT**

Mr. Cliff Patrick appeared before the Board to make a recommendation that restrooms be included for the newly renovated Unity Park. PRCA Staff, Billy Macantel, reported that restrooms were in the original plans but funding was not available.

A motion was made by Member Miles, and seconded by Member Gold, to recommend a restroom be considered for Unity park as originally planned and sent to the City Commission. Motion passed with a 5 to 2 vote with Members Johnson and Burkett in dissent.

**MEMBER COMMENT**

Member Gold expressed concern over the toxicity of our creek water stating all of our creeks are full of ecoli and some signage is needed at all locations warning visitors not to go in the water. Member Gold volunteered to investigate further and will check with the Alachua County Board on which he sits to see who has jurisdiction and what can be done.

**CHAIRPERSON COMMENTS**

Chair Johnson thanked outgoing Chair, Bill Burger, for his service and remarked that he was a tough act to follow.

The route for the May 22nd Park Tour for Board members was discussed and finalized. We will meet at 9am at the Thomas Center and leave from there.

It was decided that the PRPB Board would continue to meet in the Roberta Lisle Kline Conference Room at City Hall for the time being. We will not be meeting in the month of June, so our next meeting will be July 14, 2021.
