
Survey Results

Q: What are your favorite things that need to be protected? The top favorite things are history, local businesses, and sense of community.


Q: What are the top three changes you would like to see?







Eligible Improvement Guidelines

Per Program Guidelines Section 3, Item #2

Awnings/Canopies - including the removal of old awnings and canopies and the design, production, and installation of new awnings and canopies.






Eligible Improvement Guidelines

Per Program Guidelines Section 3, Item #3

Façade - Includes work performed on the exterior storefront of a building such as cleaning masonry (high pressure water or steam - sandblasting is prohibited on masonry structures), painting, re-pointing (filling in or repair to joints), woodwork, window and/or door replacement, and other repairs (that are not maintenance related), or rebuilding historic storefronts.


Eligible Improvements

New sidewalks increase ADA accessibility to the historic building



Eligible Improvements

- Site currently experiences flooding that extends onto Main Street (a primary corridor in the GCRA District)
- Due to code the additional impervious additions to • the property require onsite mitigation of rainfall, which requires rainwater storage tanks
- The historic building's replacement downspouts and gutters are required to take the water to the storage tanks
- Restoring original decorative building elements, like the gutters, is specifically called out as an eligible improvement in Section 3.9 of the Business Improvement Grant Program
