**RESOLUTION NO. 210115**

**A Resolution of the City Commission of the City of Gainesville, Florida, establishing the maximum parking rates for on street parking, off street parking, parking meters, parking lots and parking garages in accordance with Division 2, Article III, Chapter 26 of the Code of Ordinances of the City of Gainesville, Florida; authorizing the City Manager to establish rates up to the maximum rate; providing a repealing clause; and providing an immediate effective date.**

**WHEREAS**, Sec. 26-82 in Division 2, Article III, Chapter 26 of the Code of Ordinances of the City of Gainesville provides that maximum parking rates for on street parking, off street parking, parking meters, parking lots and parking garages be established by resolution by the City Commission.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF GAINESVILLE, FLORIDA THAT:**

**Section 1.** The City Commission establishes the maximum rate for the following categories of on-street and parking lot parking:

- (1) Short term metered zones, not exceeding 4 hours, maximum hourly rate ...\$1.00/hour
- (2) Long term metered zones, in excess of 4 hours, maximum hourly rate ... \$1.00/hour

The City Manager is authorized to establish parking meter rates provided the maximum hourly rate is not exceeded.

**Section 2.** The City Commission establishes the maximum rate for garage parking as follows:

Daytime (6:00 A.M. to 6:00 P.M.)

- (1) Hourly fee ... \$1.00/hour
- (2) Contract parking ... \$100.00 per month

Nighttime (6:00 P.M. to 6:00 A.M.)

- (1) Nightly flat rate ... \$15.00 per night
- (2) Contract parking ... \$100.00 per month
- (3) Hourly fee ... \$1.00/hour

Special Event (Event designated by City Manager)

- (1) Daily flat rate .... \$15.00 per day

... \$200.00 per month

48        The City Manager is authorized to establish parking garage rates provided the maximum  
49        rates are not exceeded.

51                **Section 3.** The City Manager is authorized to establish restricted long term parking  
52        rates provided a maximum rate of \$200.00 per month is not exceeded.

54                **Section 4.** All resolutions, or parts of resolutions, in conflict herewith are to the extent  
55        of such conflict hereby repealed.

57                **Section 5.** This Resolution shall become effective immediately upon adoption.
