# Registry of Protected Public Places Update

#### The ordinance states:

- A registry will be created for the purpose of identifying fee-simple properties owned by COG that are deemed to be worthy of the highest level of protection.
- When listed, properties may not be sold or converted to a use that will result in a loss of value for which the property was placed on the registry, except by a majority vote of the electors.



- City Commission approved amendment on December 18, 2008.
- COG citizens voted in favor of amendment on March 24, 2009.



**Registry Listing Plan** 

- Staff developed a phased listing plan.
- Phase I:
  - 11 nature parks
  - Acquired with grant funding
  - Acquired through donation
  - Deed restrictions present
  - Exemplary example of habitat



## **Phase I Registry Listing**

### RCAPW Committee recommended Phase I listing to City Commission on January 31, 2011.



Adding Phase I Properties: Ordinance #100967

- March 3, 2011, City Commission recommended 11 Phase 1 properties placed on the Registry.
- Ordinance #100967 placing the recommended 11 Phase 1 properties on the Registry was approved on first reading June 16, 2011 and adopted on final reading July 7, 2011.



## **Phase II Registry Listing Plan**

#### Phase II-A:

- 4 nature parks added
- Already zoned "Conservation" and have acquisition plans in place.

### Phase II-B (pending):

 Proposes 6 additional nature parks will be added once land use/zoning or recreational development issues have been resolved.




## **Phase II-A Registry Listing**

Phase II-A Property Listing: Ordinance #121080

- March 21, 2013 City Commission recommended Phase II-A properties be placed on the Registry.
- June 6, 2013 Ordinance #121080 placing Phase II-A properties on the Registry passed on first reading
- June 20, 2013 Passed and adopted



### **Phase III Registry Listing Plan**

Phase III anticipated to include:

- 5 parks
- May or may not be listed depending on specific issue needing to be resolved
