13	her contributions as a research physicist and as a Gainesville area high school teacher and resident;

15	WHEREAS, the City Commission wishes to change the name of the City park at Carolyn			
16	Beatrice Parker Elementary consistent with the school's new name, and in recognition and honor			
17	of Ms. Parker; and			
18	WHEREAS, the City Commission also wishes to change the name of Loblolly Woods to			
19	"Loblolly Woods Nature Park" to reflect the function and character of this park; and			
20	WHEREAS, at least ten (10) days' notice has been given once by publication in a			
21	newspaper of general circulation notifying the public of this proposed ordinance and of public			
22	hearings in the City Hall Auditorium located on the first floor of City Hall in the City of			
23	Gainesville; and			
24	WHEREAS, the public hearings were held pursuant to the notice described above at			
25	which hearings the parties in interest and all others had an opportunity to be and were, in fact,			
26	heard.

5	(18) Park located at J.J. Finley Elementary School, to be named (this is a			
6	placeholder) Carolyn Beatrice Parker Park.			
7	(b) Nature parks, centers and conservation areas:			
8	(17) Loblolly Woods <u>Nature Park</u> .			
9	Section 2. It is the intention of the City Commission that the provisions of Section 1 of			
10	this ordinance will become and be made a part of the Code of Ordinances of the City of			
11	Gainesville, Florida, and that the sections and paragraphs of this ordinance may be renumbered			
12	or relettered in order to accomplish such intentions.			
13	Section 3. If any word, phrase, clause, paragraph, section or provision of this ordinance			
14	or the application hereof to any person or circumstance is held invalid or unconstitutional, such			
15	finding shall not affect the other provisions or applications of this ordinance that can be given			
16	effect without the invalid or unconstitutional provision or application, and to this end the			
17	provisions of this ordinance are declared severable.			
18	Section 4. All ordinances or parts of ordinances in conflict herewith are to the extent of			
19	such conflict hereby repealed.			
20	Section 5. This ordinance shall become effective immediately upon adoption.
