## Continue Discussions Regarding Tree Ordinance Revisions

The board discusses the tree matrix and what it means to the City of Gainesville. Member Frank and Member Adams agree that the matrix should not include invasive trees or trees that are not recommended for planting. Member Manley States that the tree matrix has too much knowledge that is not required in codes and should be thinned down. Member Frank says that the tree matrix should not be used as an inventory of what is in Gainesville, but to find a better purpose for it. Member Manley brings up the discussion for root zone volume requirements for landscape plantings. The board discusses the topic, Member Adams says it should take into account the type of soil.
