A Resolution of the City Commission of the City of Gainesville, Florida; relating to its general government budget for the fiscal year beginning October 1, 2020 and ending September 30, 2021; amending Resolution No. 200316, as amended by Resolution No. 200933, Resolution No. 201058, Resolution No. 201115 and Resolution No. 210151 by making certain adjustments to the General Government Financial and Operating Plan Budget; and providing an immediate effective date.

WHEREAS, on September 24, 2020, the City Commission of the City of Gainesville, Florida, adopted Resolution No. 200316 for the purpose of approving and adopting a final budget for Fiscal Year 2021;

WHEREAS, on April 1, 2021, the City Commission adopted Resolution No. 200933 amending the General Government Financial and Operating Plan Budget as set forth therein;

WHEREAS, on April 15, 2021, the City Commission adopted Resolution No. 201058 amending the General Government Financial and Operating Plan Budget as set forth therein;

WHEREAS, on June 17, 2021, the City Commission adopted Resolution No. 201115 amending the General Government Financial and Operating Plan Budget as set forth therein;

WHEREAS, on September 2, 2021, the City Commission adopted Resolution No. 210151 amending the General Government Financial and Operating Plan Budget as set forth therein;

WHEREAS, it is necessary to make certain amendments to the General Government Financial and Operating Plan Budget in order to fund their activities;

WHEREAS, the City Commission desires now to amend the General Government Financial and Operating Plan Budget as fully set forth below.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE
CITY OF GAINESVILLE, FLORIDA:**

1 **Section 1.** The General Government Financial and Operating Plan Budget for Fiscal Year
2 2021 is hereby amended as set forth in Attachment "A" which is attached hereto and made part
3 hereof as if set forth in full.

4 **Section 2.** Except as herein above modified and amended, the General Government
5 Financial and Operating Plan Budget for Fiscal Year 2021 as adopted by Resolution No. 200316
6 and amended by Resolution No. 200933, Resolution No. 201058, Resolution No. 201115 and
7 Resolution No. 210151 shall continue and remain in full effect.

8 **Section 3.** This Resolution shall become effective immediately upon adoption.

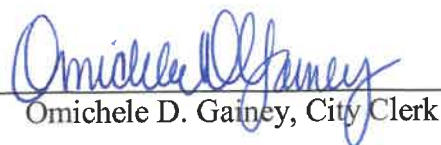
