Member Crowe was absent and unable to give his presentation. The board heard from Member Fults and discussed the following ideas:

Solar energy and the possibility of the City of Alachua surpassing GRU in amount of renewables if they can purchase solar energy from FPL.

Possible different configuration of ownership of GRU - joint city/county/school board/UF. Partnership would include Duke and Clay Electric and all citizens of the county would be GRU customers. Real savings would come from county and city merging into one.

Time of use rates would reduce peak load and cut down on need for coal and gas plants.

GRU's educational efforts - should create technical program for high schools and hire from there.

Master business plan for getting to 100% renewable. A member expressed that there doesn't seem to be a plan, but rather a piecemeal effort.

Should GRU's pole attachment policy be updated to include 5G.

Need to work on ways to improve board communication with city commissioners. Should individual UAB members meet with individual commissioners regularly? Citizen Nancy Deren spoke.
