If for any reason or no reason you have not obtained the execution of the Covenant of Use by the City on or before November 8, 2021 (hereinafter the "Escrow Termination Date"), you agree to promptly return the enclosed unrecorded, original Satisfactions of Agreements and Mortgages to EDA to my at my home as noted above. The Escrow Termination Date may be extended by a mutually agreed upon written agreement which may be the exchange of emails between EDA and the City Attorney's Office.
