### RUC CURRENT ACTION ITEMS

# **OBO421.** Evaluation of Rates for Reclaimed Water - Discussion of Proposed Changes to GRU's Reclaimed Water Policy (B)

The Regional Utilities Committee received a presentation from staff regarding reclaimed water rates and proposed changes to the reclaimed water policy which included follow-up discussion on items requested at the May 13, 2009 meeting.

A recommendation was made by staff that the RUC recommend to the City Commission approval of the proposed changes to the reclaimed water policy and keep the existing reclaimed water rate charges which are included in the ordinance changes scheduled for the September 3, 2009 City Commission meeting.

Mr. Fred Palgon, President of the Cobblefield Homeowners Association was recognized and gave a presentation to the Committee. He requested that the RUC consider a different rate for irrigating storm water basins and to allow rebates for rain sensors for reclaimed water.

Commissioner Lowe moved to approve the recommendation with these additional items to be discussed when the item comes before the full Commission: 1) staff investigate the tiered systems and/or different customer classes; 2) staff review the Waldo Road Corridor Master Plan and determine the benefits and feasibility of irrigating this corridor and what impact this would have on the Payne's Prairie Sheet flow project; and 3) have Planning staff provide comments related to the reclaimed water master plan and the proposed LDR changes needed to implement the plan. The Mayor also asked for developments on the eastside whether it would be beneficial to have a stand alone irrigation system installed served with potable water that would be

hooked to reclaimed water when it became available.

Mayor Hanrahan seconded the motion and it was approved.

**RECOMMENDATION** The Regional Utilities Committee (RUC) receive a

presentation from staff, and recommend that City Commission

approve proposed changes to GRU's reclaimed water

extension policy.
