	Diane Wilson gave a presentation on staff's research into different ways to benchmark GRU against our peers. Commissioner Poe asked that staff prepare a report for the January timeframe to compare GRU against IOU's in Florida. Commissioner Chase asked that we benchmark against all Florida		

municipal utilities across the board for electric and to be sure as much as possible that we compare apples to apples and to include taxes, fees and

surcharges. He asked that we take this item back to the full commission at one of its November meetings with a report on how we addressed each of the Chamber's four recommendations.

<u>RECOMMENDATION</u> The RUC receive a presentation from staff.

John Stanton gave a presentation on the process that GRU has developed to look at our future power needs. He emphasized that our strategic plan is not a study to determine what we should build, but rather it is a study to look at what we should do to meet our customers' needs while meeting the NERC reliability requirement within the bulk electric system. He explained that we are currently formalizing the team who will develop the plan and that the next step is to develop the overall scope and that we hope to have a draft report in approximately one year.

Commissioner Poe recommended that we give this presentation to the Committee of the Whole. Commissioner Chase agreed and hoped it could get on the agenda at the end of this year or early next year.

During the course of the presentation, Mr. Stanton said that he had done some research on The Bloom Energy Server, a type of fuel cell that was mentioned to the Commission by citizen Mark Vensky. He gave the Committee a copy of an email he had sent to Commissioner Hinson-Rawls detailing his research, a copy of which is attached to these minutes.
