Assistant City Manager Paul Folkers introduced this item. Parks, Recreation and Cultural Affairs Assistant Director Michelle Park provided the staff presentation and

update. At the February 12, 2015 RCAPW meeting, the Committee voted to request the Mayor send a letter to the Trust for Public Land (TPL) Regional Office located in Tallahassee, requesting Technical Advice and Assistance with the Commission's Strategic Initiative 6.3 to develop a program to fund the implementation of the Master Plan. TPL provides professional technical services to state and local government executives, boards and public agencies that need to research and evaluate recreation and conservation options.

At the February 19, 2015 City Commission meeting the Commission approved a request for the Mayor to send a letter to TPL's Regional Office as recommended by the Committee. In response to the Mayor's letter, TPL has provided a proposal for technical advice and assistance to support the City's efforts. TPL's findings and recommendations should be available in May, 2015. Commissioner Hinson-Rawls made the following motion, with a second by Commissioner Warren that was approved unanimously.

MOTION: The RCAPW Committee direct staff to bring the TPL proposal to the City Commission on March 19, 2015 for acceptance of the proposal and to direct the City Manager to proceed.

RECOMMENDATION

The Recreation, Cultural Affairs and Public Works Committee: 1) discuss the Trust for Public Land proposal to conduct feasibility research and provide recommendations to develop a program to fund the implementation of the Master Plan, and 2) make a recommendation to the City Commission.
