Assistant City Manager Fred Murry introduced the landlord permit issue and Chris Cooper, Code Enforcement Manager, provided a brief history of the issue and announced that the fee study had been completed. He reiterated that the Committee is being asked to consider the five staff recommendations that were presented in July

as well as recommendations from stakeholders. Finance Director, Mark Benton, explained that the fee study was made in order to determine the City's expenses as well as the percentage of Code Enforcement department's energies are dedicated to the landlord licensing efforts. It was found that the total annual cost is about \$486,000, which equals \$112-204 per permit issued. With a goal of rewarding the good actors while being more strict with those who don't follow the rules, Commissioner Wells moved that "the Community Development Committee request that the City Commission: 1) revise the permit fee to \$118, while maintaining the current Codes Enforcement budget, 2) implement a single late fee of 25%, 3) place the points process with the Special Magistrate, 4) offer the permit transfer option, but points stay with the permit and there will be hearing with the Special Magistrate, 5) clearly define what a "relative" is and have that reflected in the permit forms, 6) direct Codes to create a process now to contact landowner as well as permit contact on first contact with the property and on each violation with the property, 7) Codes utilize 311GNV to report the status of issues reported there." Commissioner Carter agreed with the motion. Mr. Benton stated, for the record, that this will make a \$415,000 difference in the FY16 budget. The Committee requested that this issue be brought before the City Commission at the September 19th regular meeting.

RECOMMENDATION

The Community Development Committee hear staff's presentation and consider the recommended actions proposed by staff.
