MEMBER COMMENT

Commissioner Budd had questions as it pertained to available bonding opportunities for small businesses looking to take on large projects. Sarah Vidal-Finn and Torey Alston both spoke to this matter.

Chair Goston had questions regarding bonding restrictions as it relates to bonding agency location, he noted there were availabilities beyond this area. Ms. Vidal-Finn added she would seek further information on this item.

Commissioner Warren commended the committee's work to date and noted she was pleased.

Commissioner Warren spoke on the various approaches and challenges as it relates to affordable housing including continuum of care, incentives and options to making affordable housing available via city and other initiatives. Chair Goston noted some policy changes would have to be implemented to assist with affordable housing. Commissioner Budd made several recommendations including developing a housing strategic plan. The committee agreed.

Chair Goston recognized city and county housing staff who provided their guidance and expertise regarding affordable housing and available options.

Assistant City Manager, Fred Murry discussed prior efforts by the county and city and the challenges involved. Mr. Murry noted that efforts will require the support of various agencies and educating citizens on affordable housing and fiscal responsibility to ensure they are able to keep and maintain housing once obtained.
