1) Meeting Schedule

Samantha Wolfe reminded the Committee that May 4, 2017 is the date slated to present their recommendations to the City Commission. She requested a convenient time be identified. Members suggested that a presentation during the evening meeting would be preferable.

Members discussed continuing to meet on an informal basis, less frequently.

Reconvene to see how things are going and to discuss new opportunities. Continue to advocate for the ideas that will move the community forward. The committees can report back at different intervals to report progress.

#### 2) Presentation of Recommendations

Members agreed that every item needs to be articulated, actionable, identifiable and specific. The City Commission should endorse those items in a proclamation and approve. Alachua County and the Alachua County School Board could do the same. Committee members need to deliver the presentation to the City Commission, not just staff. Our charter was to come up with continuous improvement efforts. Sub-committees can be formed and we can volunteer to serve on the committees we feel most passionate about. Each big idea should have at least one citizen member who serves as an ambassador to move the projects forward.

Chair Thorpe shared during a phone call with Samantha Wolfe that the first and next steps should be included in the committee recommendations. To ensure greater buy-in, he also requested that we schedule one-on-one meetings with each City Commissioner the week of the presentation. Samantha Wolfe is working with the Commission staff to schedule those appointments.
