	 CFO Justin Locke gave a presentation with new information that resulted from the budget presentation to the City Commission on July 11, 2017 as well as info requested by the UAB at their July 5, 2017 meeting. After much discussion amongst the members and staff, Member Walpole made the following motion: 1) Approve budget subject to no additional funding being provided to branding and PR efforts; 2) Maintain two tier electric rate system for 2018; 3) No electric increase by lowering GFT by 2.4 million for 2018; 4) Holding 2.4 million decrease in 2019 to keep the rate increase to 1% for 2019; 5)Maintain capital expenses at no more than \$85 million, which is plugged into the current projection model.
