The Board and the City Commission discussed the issue of the UAB working on a draft ordinance to create an independent utility board. Board members explained that they felt it was important for citizens to have an alternative to the Clemens/Perry bill and that they thought the Board's charter as written gave them authority to work on any matter they choose related to GRU. The Commission expressed concern that having citizens vote on an IUB in both the spring and fall elections would be confusing and may not produce a good outcome.

The rest of the discussion centered on examining the existing structure of the UAB now that they are a little past their first year in existence, to determine the feasibility of giving the board expanded powers. The Mayor suggested holding a joint workshop to set priorities and review the Board ordinance for possible changes. Member Selvester made a motion to continue the governance discussion at a workshop. The motion was seconded by Sandy Campbell and passed 6-0, with Mary Alford absent.

Citizens Jim Konish, Debbie Martinez, Susan Bottcher, Ernesto Martinez and Joe Little spoke to the matter.
