Member Orlando made a motion and Member Alford seconded to ask the City Commission to appoint a UAB member to sit on the Broadband Sub-Committee.

Member Selvester made a motion, seconded by Member Walpole to reduce the General Fund Transfer in an amount equoate to the increase in the utility tax and the savings be evenly distributed among all rate payers in every rate class and be used for no other purpose. The motion passed 5-2, with members Alford and Denslow in dissent.

Regarding whether board members should be required to complete financial disclosure and conflict of interest forms, Member Orlando made a motion that the Board follow the state statute on advisory boards. The motion was seconded by Member Alford and passed unanimously.
